## Conversion of Unlisted Options and Cleansing Notice

Meeka Metals Limited (“**Meeka**” or the “**Company**”) provides this notice under section 708A(5)(e) of the Corporations Act in relation to the issue today of 7,687,500 fully paid ordinary shares in the Company.

The shares have been issued following the conversion of:
