8.8.1	Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?	
	<p>Answer: No, the Company's exploration-based expenditures and even administration are variable by nature and are adjusted to fit the Company's available funds as required from time to time. The Company deliberately has flexibility built into its forward work programs, and spending commitments will not be made without certainty of the Company's ability to meet those commitments when they fall due.</p> <p>The Company has disposed of its tenements in Finland (subject to completion), and is also seeking a JV / funding partner for several other projects providing suitable terms are able to be obtained.</p>	
8.8.2	Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?	
	<p>Answer: Yes, the Company obtained loan funds of \$400,000 as set out in Section 7 above.</p> <p>The lenders, Mr Mason and Mr Stuart have indicated they may provide further loan facilities to the Company.</p> <p>Subsequent to quarter-end the Company also raised \$205,000 in a share placement with a further \$95,000 to be subscribed following a General Meeting to be held in May 2024. This placement is part of a proposed \$500,000 placement and a proposed Rights Issue for \$500,000, also announced subsequent to quarter end.</p> <p>The Company has disposed of its tenements in Finland (subject to completion) is also in discussions to potentially sell some of its other tenements.</p> <p>The Company also holds a substantial shareholding position of 10 million shares approximately in Lakes Blue Energy NL (ASX-LKO), and these shares are quoted on ASX (currently suspended). At the last traded share price for LKO shares on ASX these LKO shares have a value of approximately \$10 m. The Company has previously disposed of 125 million shares in LKO off market at \$0.0008 for proceeds of \$100,000.</p> <p>Based on its track record, and that of its Directors, the Company is confident that its future treasury management and capital raising initiatives will continue to be successful.</p>

Answer: Yes, in addition to the capital raisings, asset sales and loan facility already undertaken and announced in the 12 months ended 31 March 2024, the Directors remain confident in the Company's projects, the value of its shareholding in Lakes Blue Energy, and in the Company's ability to continue to raise capital as required to fund the business.
