### Section 708A(5)(e) on-sale cleansing notice – issue of placement shares

#### TasFoods Ltd (ASX: TFL)

TasFoods Ltd (**ASX: TFL**) (**Company**) has today issued 30,000,000 fully paid ordinary shares at a price of \$0.10 per share to raise \$3,000,000 (**Placement Shares**) by way of a placement to AgFood Opportunities Fund as outlined in the Company's announcement dated Wednesday, 25 November 2020.
