Brookside Energy Advances Bruins Well Operations Drilling Completed Ahead of Schedule, Production Casing Installed

Perth, Western Australia – Brookside Energy Limited (ASX: BRK) (OTC Pink: RDFEF) (Brookside or the Company) is pleased to announce a significant operational milestone for the Bruins Well located in the high-impact SWISH Area of Interest (AOI) in the Anadarko Basin, Oklahoma. Drilling operations have now been completed and the well has been safely secured, with production casing successfully run and cemented in place.

The well successfully reached its planned total measured depth (TD) of approximately 16,718 feet, with the lateral accurately positioned within the targeted Woodford Shale. Numerous oil and gas shows confirm pre-drill expectations for the Bruins Drilling Spacing Unit (DSU). Importantly, drilling operations were executed safely and efficiently, achieving target depth and successfully installing production casing in just 30 days—well ahead of schedule. This achievement underscores Brookside's ability to execute with discipline and cost control, driving value for shareholders.

Kenai Rig 19 is now being demobilised as Brookside prepares for the next phase—construction and installation of surface production facilities—positioning the Bruins Well for the commencement of completion operations and, ultimately, production and cash flow generation.

Brookside Energy Managing Director David Prentice commented:

"Successfully completing the drilling phase ahead of schedule underscores our team's operational excellence and ability to create shareholder value through disciplined execution. The Bruins Well represents a key step in unlocking the full potential of our Bruins DSU, and we remain focused on delivering optimal production and cash flow outcomes from this well in the near term."

Development Unit or DSU	Development Unit or drilling spacing unit is the geographical area in which an initial oil and/or gas well is drilled and produced from the geological formation listed in a spacing order. The spacing unit communitizes all interest owners for the purpose of sharing in production from oil and/or gas wells in the unit. A spacing order establishes the size of the unit; names the formations included in the unit; divides the ownership of the unit for the formations into the "royalty interest" and the "working interest;" Only one well can be drilled and completed in each common source of supply. Additional wells may be drilled in a Development Unit, but only after an Increased Density Order is issued by the Oklahoma Corporation Commission.
Force Pooled	The Oklahoma Corporation Commission is authorized to establish well spacing and drilling units covering any common source of supply of hydrocarbons, or any prospective common source of supply. Once the unit is established, the Commission can force pool the interests of all the owners who own interests in that unit and who have not voluntarily joined in the development of that unit.
