## EXERCISE OF LISTED OPTIONS

Nusantara is pleased to report that major shareholder Lion Selection Group Limited has exercised 3,750,000 listed options at A\$0.30 each into fully paid ordinary shares. In addition, the Company has been advised by Directors Mr Greg Foulis, Mr Robin Widdup and Alternate Director Mr Craig Smyth that they have or intend to exercise 634,566 listed options they hold.

The Company notes that the listed options trading under ticker symbol NUSOA that are exercisable at A\$0.30 each into fully paid ordinary shares, expire 31 July 2020. The Company's share registry, Computershare, is administering the exercise process for holders of listed options seeking to exercise them into fully paid ordinary shares.

For administration purposes listed options exercised are being converted in tranches. Please find attached the Appendix 2A to recognise 3,988,748 exercised up to 23 July 2020.
