

Notice in accordance with Section 708A(5)(e) of the Corporations Act 2001 (Cth)

Warrego Energy Limited (ASX: WGO) (**Company**) has today issued 631,874 fully paid ordinary shares in the Company (**Shares**) upon the vesting of 631,874 share rights.

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A of the Act. By giving this notice, a sale of the Shares noted above will fall within the exemption in section 708A(5) of the Act.

 - ii. the rights and liabilities attaching to the relevant Shares.
