ISSUE OF EIGHTH CONVERTIBLE NOTE TO ARENA

Genex Power Limited (**ASX: GNX, Genex** or the **Company**) is pleased to advise that it has now received the eighth instalment of \$186,782.00 from the Australian Renewable Energy Agency (**ARENA**) in respect of the federal government funding approved by ARENA as announced to the market on 18 December 2015.

The receipt of this eighth instalment from ARENA brings the total instalments received to more than \$2.37m. The funds will continue to be applied towards the development of the Company's Pumped Storage Hydro Project at Kidston.

Under the terms of the Funding Agreement with ARENA, Genex has issued an eighth Convertible Note for which an Appendix 3B is attached.
