Tarney has agreed to subscribe for approximately \$0.5 million worth of shares on the same terms as the placement (as announced to the ASX on 8 July



2025) at a deemed issue price of 1.1 cents per Share, being the same price paid by all investors under the placement. The amount payable by Tarney for such Shares shall be applied to repayment all amounts (inclusive of accrued interest) re-payable to Tarney under the Loan Facility.
