Correction Letter – Correction of Previous Appendix 3Y & Issue of New Appendix 3Y

Midas Minerals Ltd (ACN 625 128 770) (ASX: MM1) (**Company**) refers to:

- (a) the previous Appendix 3Y lodged with ASX in respect of Mr Calderwood dated 15 June 2023 (**Previous Appendix 3Y**); and
- (b) the Appendix 3Y lodged with ASX in respect of Mr Mark Calderwood dated 26 June 2023 (**New Appendix 3Y**).

The Company confirms that, due to a clerical oversight:

- (a) the Previous Appendix 3Y incorrectly recorded that:
 - (i) Ms Delphine Faith Calderwood, being the spouse of Mr Mark Calderwood, had a relevant interest in 50,000,000 fully paid ordinary shares (**Shares**) in the capital of the Company (**Incorrect Share Number**), both before and after the on-market trades the subject of the Previous Appendix 3Y; and
 - (ii) on 14 June 2023, Mr Calderwood (in his personal capacity) acquired a relevant interest in 50,000 Shares on-market at an average price of \$0.2275 per Share;
- (b) the Incorrect Share Number should have instead referred to 50,000 Shares (**Share Parcel**) (in both instances); and
- (c) the 50,000 Shares acquired by Mr Calderwood on 15 June 2023 were acquired by Mr Calderwood (as trustee for the Mark Calderwood Family Trust), not in his personal capacity.

The purpose of the New Appendix 3Y is to record that, on 26 June 2023, Mr Calderwood acquired a relevant interest in 2,000,000 performance rights on the terms and conditions set out in the New Appendix 3Y.

The Company confirms that this document has been authorised for release by its board of directors.
