	The company has loan facilities in place with banks in Italy, Brazil and USA with interest rates varying from 1% to 12%. The majority of these loans are unsecured. The company has unsecured bank guarantees in place in Italy. On 29 July 2020, the Group entered into a loan agreement with an affiliate of Upwell LLC to provide an initial \$20 million finance facility (the "Facility"). On 10 December 2021 the facility has been increased to \$30.3 million. The Facility is available to finance recurring revenue projects (i.e BOOT) and Fluence working capital.
