

## 2020 RENISON RESOURCE & RESERVE UPDATE

Metals X Limited (**Metals X** or the **Company**) is pleased to provide its annual update of Mineral Resources and Ore Reserves for the Renison Tin Operation (**Renison**) in Tasmania. Renison is 50%-owned by Metals X through the Bluestone Mines Tasmania Joint Venture (**BMTJV**).

- New Mineral Resource and Ore Reserve estimations completed for Renison as at 31 March 2020.
- 46% increase in Ore Reserves at the Renison underground tin (**Sn**) mine, increasing from 82,360 tonnes of contained tin to 120,300 tonnes of contained tin.
  - Total Renison Proved & Probable Ore Reserve of 8.61 Mt at 1.40% Sn for 120,300 tonnes of contained tin.
  - Area 5 Ore Reserve of 3.3 Mt at 1.87% Sn for 61,900 tonnes of contained tin, including 2.2 Mt at 2.11% Sn for 46,400 tonnes of contained tin from a distinct high-grade portion of the Mineral Resource.
  - Mineral Resources above 955mRL are included in the Ore Reserve estimate, the deposit remains open below this level with drilling continuing.
- The continuing commitment to Mineral Resource development drilling has once again delivered strong results with defined tin in Measured and Indicated Resources increased by 12% (26,500 tonnes) and average tin grades increased by 6% (0.09% Sn) when compared to 31 March 2019 (after mining depletion).
  - Total Renison Measured, Indicated and Inferred Resource of 18.55 Mt at 1.57% Sn for 291,600 tonnes of contained tin.
- The on-going exploration program aims to increase the Ore Reserves, net of depletion, each year with a range of exploration targets identified.

### Chief Executive Officer, Mr Mike Spreadborough, commented:

*"Renison is a world class tin deposit and Australia's largest primary tin producer. The results from the 2020 Mineral Resource and Ore Reserve update represent yet another outstanding year for the operation and will support a mine life in excess of 10 years.*

*After our significant exploration success during 2018 and 2019, I am excited to report a maiden Ore Reserve for Area 5 hosting some 61,900 tonnes of contained tin at a grade of 1.87% Sn, with further resources still available at depth. As we ramp-up production in this area we will see the expected increase in mined tin grades flowing through the operation.*

*Going forward, our aim at Renison is to continue to increase Ore Reserves net of depletion each year and I commend the ongoing excellent work of the BMTJV team in this regard".*

## Key Assumptions and JORC 12 Requirements

Mineral Resources are reported inclusive of Ore Reserves. Mining production data up to 31 March 2020 and all exploration information has been included. Mineral Resources have been depleted for mining to 31 March 2020.

The tin price assumption used to estimate Mineral Resources and Ore Reserves was US\$15,275 to \$17,250/t Sn at an assumed exchange rate of USD/AUD 0.65 to 0.69 giving a price of AUD \$23,500 to \$25,000/t Sn.

The Mineral Resources and Ore Reserves have been classified in accordance with the guidelines set out in the Australasian Code for Reporting Exploration Results, Mineral Resources and Ore Reserves, published by the Joint Ore Reserves Committee (JORC), of the Australasian Institute of Mining and Metallurgy, the Australian Institute of Geoscientists and the Minerals Council of Australia, December 2012 (the 'JORC Code' or 'JORC 2012').

The full Mineral Resource and Ore Reserve estimates for the Renison Tin Operation are tabulated in Table 1 and Table 2 respectively.

Material Information for the individual deposits, including a summary of material information pursuant to ASX Listing Rules 5.8 and 5.9 and the Assessment and Reporting Criteria in accordance with JORC 2012 requirements, is included in the body of this report and in Appendix B to this announcement.

## Mineral Resource and Ore Reserve Governance Statement

In accordance with ASX Listing Rule 5.21.5, governance of the Company's Mineral Resources and Ore Reserves development and management activities is a key responsibility of the Executive Management of the Company.

Senior geological and mining engineering staff of the Company oversee reviews and technical evaluations of the estimates and evaluates these with reference to actual physical, cost and performance measures. The evaluation process also draws upon internal skill sets in operational and project management, ore processing and commercial/financial areas of the business.

The Executive General Manager Geology (in consultation with BMTJV senior staff) is responsible for monitoring the planning, prioritisation and progress of exploratory and resource definition drilling programs across the Company and the estimation and reporting of Mineral Resources and Ore Reserves. These definition activities are conducted within a framework of quality assurance and quality control protocols covering aspects including drill hole siting, sample collection, sample preparation and analysis as well as sample and data security.

A four-level compliance process guides the control and assurance activities:

- Provision of internal policies, standards, procedures and guidelines.
- Mineral Resource and Ore Reserve reporting based on well-founded geological and mining assumptions and compliance with external standards such as the JORC Code.
- Internal review of process conformance and compliance.
- Internal assessment of compliance and data veracity.

The Executive Management aims to promote the maximum conversion of identified mineralisation into Mineral Resources and Ore Reserves compliant with JORC 2012.

The Company reports its Mineral Resources and Ore Reserves, as a minimum, on an annual basis, in accordance with ASX Listing Rule 5.21 and clause 14 of Appendix 5A (the JORC Code).

Competent Persons named by the Company are members of the Australasian Institute of Mining and Metallurgy (AusIMM) and/or the Australian Institute of Geoscientists (AIG), and qualify as Competent Persons as defined in the JORC Code.

## Mineral Resource Estimates

Table 1 shows the updated Mineral Resource estimate for the Renison Tin Operation at 31 March 2020.

### Summary of Material Information

Appendix B to this report contains all information material to understanding the estimates of Mineral Resources. In accordance with Listing Rule 5.8.1, the following summary of material information in this regard is provided below.

#### Geology and geological interpretation

Renison is one of the world's largest operating underground tin mines and Australia's largest primary tin producer. Renison is the largest of three major skarn, carbonate replacement, pyrrhotite-cassiterite deposits within western Tasmania. The Renison Mine area is situated in the Dundas Trough, a province underlain by a thick sequence of Neoproterozoic-Cambrian siliciclastic and volcanoclastic rocks. At Renison there are three shallow-dipping dolomite horizons which host replacement mineralisation. The major structure associated with tin mineralisation at Renison, the Federal Basset Fault, was formed during the forceful emplacement of the Pine Hill Granite during the Devonian and is also an important source of tin mineralisation.

#### Drilling techniques, sampling and sub-sampling techniques

The bulk of the data used in resource calculations at Renison has been gathered from diamond core using NQ2, LTK60 and LTK48 sizes. This core is geologically logged and subsequently halved for sampling. Drill hole samples may be whole-cored to streamline the core handling process if required. Each development face / round is horizontally chip sampled with the sampling intervals being dominated by geological constraints. Sludge drilling is performed with an underground production or development drill rigs (nominal 64mm-89mm diameter hole). It is an open hole drilling method using water as the flushing medium.

#### Criteria for classification

Resources are classified in line with JORC guidelines utilising a combination of various estimation derived parameters, the input data and geological / mining knowledge. This approach considers all relevant factors and reflects the Competent Person's view of the deposit. At Renison, material classified as Measured must have development (with face samples) within 20 m. Indicated Mineral Resource must have sufficient grade and geological continuity with drill hole intersections generally between 40 m and 20 m apart. Inferred Mineral Resource is material that is defined by drill holes greater than 40m apart. Geological continuity may be present, but the grade estimate is lower in confidence.

### Sample analysis method

Samples are dried at 90°C, then crushed to <3mm, samples are then riffle split to obtain a sub sample of approximately 100 g which is then pulverized to 90% passing 75 um. A 2g subsample of the pulp sample is then weighed with 12 g of reagents including a binding agent, the weighed sample is then pulverized again for one minute. The sample is then compressed into a pressed powder tablet for introduction to the XRF. Sn, As and Cu have a detection limit 0.01%, Fe and S detection limits are 0.1%. Each XRF batch of twenty consists of one blank, one internal standard, one duplicate and a replicate. Anomalous assay results are re-assayed to ensure quality control.

### Estimation methodology

All modelling and estimation work undertaken by BMTJV is carried out via Leapfrog™ and Surpac Vision™ software by creating three-dimensional ore body wireframes using sectional techniques. Drill hole intersections within the three-dimensional wireframes are composited and statistical analysis is conducted to determine appropriate search parameters within individual domains. An empty block model is created, and grade estimation is undertaken using ordinary Kriging estimation methods. The resource is then depleted using mining voids and subsequently classified in line with JORC guidelines as above.

### Cut-off grades

The Mineral Resource reporting cut-off grade is 0.7% Sn at Renison Bell.

### Mining and metallurgical methods and parameters

The Renison mine predominantly applies up-hole benching and open stoping mining methods with (in some cases), post fill and cemented rock fill to fill voids. A slurry type of fill is assumed to be used to backfill a portion of the stope voids of the high-grade wide ore zone in Area 5. A mining dilution of 5% to 15% at zero grade is used to estimate the Ore Reserve. Minimum widths for underground development are 4.5 m and for stoping minimum widths are 2.0 m. Historical Mining recoveries of 75 to 98% are applied to estimate the Ore Reserve. No Inferred Mineral Resources are included within the Ore Reserve.

The Renison mine produces a tin concentrate of grade varying between 50-60% Sn with internal process designed to reduce penalty metals such as iron, sulphur, tungsten and copper. The metallurgical process is complex and applies several stages of gravity-type concentration as well as sulphide and oxide flotation, regrinding and acid leach methods. The metallurgical recovery is estimated from plant feed grades and is based on historical plant performance with modifying factors for different ore sources. Metallurgical recoveries on the various ore types and grades were considered as part of the cut-off grade analysis.

### **Annual comparison of Mineral Resources**

Tables 3 and 4 compare the 31 March 2019 Mineral Resource estimate with the updated Mineral Resource estimate as at 31 March 2020 for the Renison Tin Operation. MLX equity share is 50% of the Mineral Resource estimates shown below.

## Ore Reserve Estimate

Table 2 shows the updated Ore Reserve estimate for the Renison Tin Operation at 31 March 2020.

### Summary of Material Information

The updated Renison Bell Ore Reserve estimate reported in Table 2 is based on the updated Mineral Resource estimate as at 31 March 2020 with modifying factors applied. The modifying factors and associated criteria used in determining the Ore Reserve are summarised below, in accordance with ASX Listing Rule 5.9.1, and detailed in Appendix B:

- Geological models used in the estimation are summarised in Appendix B: Table 1, Section 3: Modelling Techniques;
- Cut-off grade was determined based on actual unit costs currently being experienced at the Renison operation;
- Tin price assumption of US\$15,275/t to US\$17,250/t at an assumed exchange rate of USD/AUD 0.65 to 0.69 for a price of AUD \$23,500/t to AUD \$25,000/t Sn;
- Open stoping and up hole benching is assumed as per current operations;
- Underground stoping uses mining recovery factors of between 75% and 98% depending on the individual stoping block, with some minor stoping areas as low as 50% in closure pillars. Additionally, mining dilution of between 5% and 15% with zero grade has been applied to individual stopes blocks;
- Metallurgical recoveries applied to produce tin concentrate from ore are based on historical and current recoveries in the operating Renison Tin Concentrator based on a regression analysis of the grade recovery curve with modifying factors for different ore types;
- The operation is fully permitted allowing production to continue for the life of mine.

## Annual Comparison of Ore Reserves

Table 5 compares the 2019 Ore Reserve estimate, as at 31 March 2019, with the updated Ore Reserve estimate as at 31 March 2020 for the Renison Tin Operation. The Ore Reserve estimate for Rentails has not been updated since 31 March 2017 (reported on 28 August 2017).

MLX equity share is 50% of the Ore Reserve estimates shown below. Ore Reserves are a subset of the Mineral Resource estimate.
