### 1 Introduction

This Explanatory Memorandum has been prepared for the information of Shareholders in connection with the business to be conducted at the Meeting.

This Explanatory Memorandum should be read in conjunction with and forms part of the Notice. The purpose of this Explanatory Memorandum is to provide information to Shareholders in deciding whether or not to pass the Resolutions.

### 2 Action to be taken by Shareholders

Shareholders should read the Notice including this Explanatory Memorandum carefully before deciding how to vote on the Resolutions.

The Company advises that a poll will be conducted for all Resolutions.

#### 2.1 Proxies

A Proxy Form is attached to the Notice. This is to be used by Shareholders if they wish to appoint a representative (a 'proxy') to vote in their place. All Shareholders are invited and encouraged to attend the Meeting or, if they are unable to attend in person, sign and return the Proxy Form to the Company in accordance with the instructions set out in the Proxy Form. Returning the Proxy Form to the Company will not preclude a Shareholder from attending or (subject to the voting exclusions set out in the Notice) voting at the Meeting in person.

Please note that:

- (a) A Shareholder entitled to attend and vote at the Meeting is entitled to appoint a proxy;
- (b) a proxy need not be a Shareholder; and
- (c) a Shareholder entitled to cast two or more votes may appoint two proxies and may specify the proportion or number of votes each proxy is appointed to exercise. Where the proportion or number is not specified, each proxy may exercise half of the votes.

Proxy Forms must be received by the Company no later than 10:00am (AWST) on Sunday, 14 April 2024, being at least 48 hours before the Meeting.

The Proxy Form provides further details on appointing proxies and lodging Proxy Forms.

## 2.2 Attendance at Meeting

To vote in person, Shareholders are able to attend the Meeting at the time, date and place set out above. Based on the best information available to the Board at the time of the Notice, the Board considers it will be in a position to hold an 'in person' meeting to provide Shareholders with a reasonable opportunity to participate in and vote at the Meeting.

# 3 Background

## 3.1 Background to Placement

On 19 February 2024, the Company announced a capital raising comprising a placement to institutional, professional and sophisticated investors, and subject to Shareholder approval, the participation of Tribeca and Directors including Messrs Ian Middlemas, Thomas Line, Haydn Smith, Ryan de Franck and Mark Pearce in the Placement, to raise a total of \$2,100,000 (before costs) (**Placement**).

The Placement comprises the issue of 60,000,000 Shares (**Placement Shares**) at an issue price of \$0.035 per Share as follows:

- (a) 42,693,090 Placement Shares issued to institutional, professional and sophisticated investors identified by the Company under the Company's existing Listing Rule 7.1 placement capacity (19,115,221 Shares) and Listing Rule 7.1A placement capacity (23,577,869 Shares). These Placement Shares were issued on 26 February 2024;
- (b) 9,411,910 Placement Shares issued to Tribeca, subject to Shareholder approval pursuant to Resolution 2;
- (c) 3,320,000 Placement Shares issued to Mr Ian Middlemas (Chairman) (and/or his nominee(s)), subject to Shareholder approval pursuant to Resolution 3;
- (d) 575,000 Placement Shares issued to Mr Thomas Line (CEO and Managing Director) (and/or his nominee(s)), subject to Shareholder approval pursuant to Resolution 4;
- (e) 2,000,000 Placement Shares issued to Mr Haydn Smith (Non-Executive Director) (and/or his nominee(s)), subject to Shareholder approval pursuant to Resolution 5; and
- (f) 1,000,000 Placement Shares issued to Mr Ryan de Franck (Non-Executive Director) (and/or his nominee(s)), subject to Shareholder approval pursuant to Resolution 6; and
- (g) 1,000,000 Placement Shares issued to Mr Mark Pearce (Alternate Director to Mr Ian Middlemas) (and/or his nominee(s)), subject to Shareholder approval pursuant to Resolution 7.

Resolution 2 seeks Shareholder approval for the participation of Tribeca in the Placement.

Resolutions 3 to 7 (inclusive) seek Shareholder approval for the participation of Directors in the Placement.

Resolution 8 seeks Shareholder approval to ratify the issue of 19,115,221 Placement Shares under Listing Rule 7.1 pursuant to the Placement. Resolution 9 seeks Shareholder approval to ratify the issue of 23,577,869 Placement Shares issued under Listing Rule 7.1A pursuant to the Placement.

Proceeds from the Placement will be applied towards the continued exploration and development of the Company's flagship Dante Project in Western Australia, including a maiden drilling program, and to provide funds for general working capital.

Bell Potter Securities Limited (**Bell Potter**) acted as sole lead manager to the Company in the Placement.

Please refer to the Company's ASX announcement dated 19 February 2024 for further details regarding the Placement.

On 13 March 2024, the Company announced that it had agreed to issue Bell Potter 1,000,000 options (\$0.07 exercise price, expiring 16 June 2027) in connection with Bell Potter's assistance with the Placement.

## **4 Resolution 1 – Change of Company Name**

### **4.1 General**

- (c) the Placement Shares are fully paid ordinary shares in the capital of the Company and rank equally in all respects with the Company's existing Shares on issue;
- (d) the 19,115,221 Placement Shares were issued at an issue price of \$0.035 per Share, raising approximately \$669,033;
- (e) the Placement Shares were issued on 26 February 2024;

## 9 Resolution 10 – Issue of Incentive Options to Mr Thomas Line

### 9.1 General

Resolution 10 seeks Shareholder approval, pursuant to Listing Rule 10.11, Part 2D.2 of the Corporations Act (including sections 200D and 200E of the Corporations Act) and for all other purposes, for the issue of:

- (a) 2,500,000 unlisted options, exercisable at \$0.07 each, on or before 16 June 2027;
- (b) 2,500,000 unlisted options, exercisable at \$0.09 each, on or before 16 June 2027; and
- (c) 2,500,000 unlisted options, exercisable at \$0.14 each, on or before 30 June 2028,

to Mr Thomas Line (and/or their nominee(s)), as part of the long-term incentive component of his remuneration as Managing Director and CEO of the Company (**Incentive Options**).

The Board considers that the grant of Incentive Options to Mr Line is a cost effective and efficient reward for the Company to appropriately incentivise the continued performance of Mr Line, and is consistent with the strategic goals and targets of the Company.

Mr Line is an experienced geologist, project generator and executive with over 10 years' experience in mining, exploration and resource development.

Mr Line was appointed as the CEO and Managing Director of the Company on 30 October 2023.

The terms and conditions of the Options to be granted to Mr Line (and/or his nominee(s)) are summarised in Schedule 2.

Resolution 10 is an ordinary resolution.

The Chairperson intends to exercise all available undirected proxies in favour of Resolution 10.

### 9.2 Section 208 of the Corporations Act

In accordance with section 208 of the Corporations Act, in order to give a financial benefit to a related party, the Company must obtain Shareholder approval, unless the giving of the financial benefit falls within an exception under sections 210 to 216 of the Corporations Act.

Mr Line is a related party of the Company for the purposes of section 208 of the Corporations Act. The issue of Options to Mr Line (and/or his respective nominee(s)) constitutes the giving of financial benefit for the purposes of section 208 of the Corporations Act.

Section 211 of the Corporations Act provides an exception to the requirement to obtain Shareholder approval for giving a financial benefit if:

- (a) the benefit is remuneration of a related party as an officer (including a Director) of the Company; and
- (b) to give the remuneration would be reasonable given the circumstances.

The Board (excluding Mr Line) considers that the proposed issue of Options to Mr Line (and/or his respective nominee(s)) is reasonable in all the circumstances and that the exception in section 211 of the Corporations Act applies. Accordingly, the Board (excluding Mr Line) considers that Shareholder approval under section 208 of the Corporations Act is not required for the issue of Options (and/or his respective nominee(s)).

### 9.3 **Listing Rule 10.11**

Refer to Section 5.2 for a summary of Listing Rule 10.11.

In accordance with Listing Rule 10.11, the Company must not issue securities to a related party of the Company unless it obtains Shareholder approval.

The effect of passing Resolution 10 will be to allow the Company to issue up to 7,500,000 Incentive Options to Mr Line (and/or his nominee(s)) respectively, without using the Company's 15% Placement Capacity under Listing Rule 7.1.

As Shareholder approval is sought under Listing Rule 10.11, approval under Listing Rule 7.1 is not required, in accordance with Listing Rule 7.2, exception 14.

If Resolution 10 is passed, the Company will be able to proceed with the issue of Incentive Options to Mr Line (and/or his nominee(s)).

If Resolution 10 is not passed, the Company will not be able to proceed with the issue of Incentive Options to Mr Line (and/or his nominee(s)) and may consider alternative forms of remuneration for Mr Line.

### 9.4 **Specific information required by Listing Rule 10.13**

Listing Rule 10.13 requires that the following information be provided to Shareholders for the purpose of obtaining Shareholder approval for the grant of the Options to Mr Line (and/or their nominee(s)):

- (a) the Incentive Options will be granted to Mr Line, the Managing Director and CEO of the Company (and/or his nominee(s));
- (b) Mr Line is a related party under Listing Rule 10.11.1;
- (c) the maximum number of Incentive Options to be granted to Mr Line (and/or his nominee(s)) is 7,500,000;
- (d) the material terms of the Incentive Options are detailed in Schedule 2;
- (e) the Company will grant the Incentive Option no later than 1 month after the date of the Meeting;
- (f) the Incentive Options will be granted for nil consideration;
- (g) the Incentive Options granted to Mr Line have a total value of \$190,000 according to the Black Scholes Option Pricing Model;
- (h) the Incentive Options as a cost effective and efficient reward for the Company to appropriately incentivise the continued performance of Mr Line and is considered by the Board to be consistent with the strategic goals and targets of the Company;
- (i) the current remuneration package of Mr Line consists of a fixed remuneration component of \$250,000 per annum plus statutory superannuation and may be paid a discretionary performance bonus upon the achievement of relevant key performance indicators to be determined by the Company. In addition, Mr Line was previously issued 7,000,000 performance rights in the Company, as approved by shareholders on 25 October 2023, as part of his remuneration arrangements;
- (j) the Incentive Options are being issued pursuant to Mr Line's roles as Managing Director and CEO; and
- (k) a voting exclusion statement is included in the Notice for the purposes of Resolution 10.

#### 9.5 **Section 200B of the Corporations Act**

In accordance with section 200B of the Corporations Act, a company may only give a person a benefit in connection with their retirement from a managerial or executive office, or position of employment in the Company or a related body corporate if:

- (a) it is approved by shareholders under section 200E of the Corporations Act; or
- (b) an exemption applies.

Section 200B of the Corporations Act applies where the benefit given to managerial or executive officers of the company, which includes a member of Key Management Personnel. Mr Thomas Line is a member of Key Management Personnel as Managing Director and CEO of the Company.

The benefits for which approval is being sought under Resolution 10 include benefits that may result from the Board exercising its discretion to waive any vesting conditions (subject to compliance with the Listing Rules) in relation the Incentive Options.

Refer to Schedule 2 for the terms and conditions of the Incentive Options.

#### 9.6 **Specific information required by section 200E of the Corporations Act**

Section 200E of the Corporations Act provides that the following information be provided to the Shareholders for the purpose of obtaining Shareholder approval for the grant of Incentive Options to Mr Line:

- (a) the amount or value of the Incentive Options proposed to be issued to Mr Line pursuant to Resolution 10 is \$190,000 based on a Black Scholes Option Pricing Model as at the date of this Notice. The value of the Incentive Options will change and depend on:
  - (i) the number of Incentive Options held by Mr Line prior to ceasing the directorship with the Company;

  - (iii) the circumstances of, or reasons for, ceasing the directorship with the Company and the Board exercising its discretion to waive any vesting conditions (subject to compliance with the Listing Rules);
  - (iv) the market price of the Shares on ASX upon the conversion of Incentive Options into Shares; and
  - (v) the risk-free rate of return in Australia and the estimated volatility of the Company's Shares on ASX at the relevant time, and
  - (vi) the Company intends to calculate the value of the benefit relating to the Incentive Options, at the relevant time, based on the above factors.
