Cadence Capital Limited – Request for Trading Halt

Pursuant to Listing Rule 17.1 Cadence Capital Limited (“the Company”) requests a trading halt in respect of its shares (ASX: CDM) effective immediately.

The trading halt is requested as the Company is seeking to place up to 15% of its issued share capital (37.9 million fully paid ordinary shares, or \$54.2M), pursuant to ASX Listing Rule 7.1.

The Company requests that the trading halt remain in place until the earlier of the opening of trading on Thursday 1st October 2015, or the time that the company makes an announcement.

The Company is not aware of any reason why the trading halt should not be granted or of any other information necessary to inform the market about the trading halt.
