# enCore Energy expands extraction capacity and accelerates wellfield development

Boss Energy Limited (ASX: BOE|OTCQX: BQSSF) (**Boss**) advises that enCore Energy Corp (NASDAQ: EU|TSXV: EU) (**enCore**) has provided a further update on the Alta Mesa Project in Texas, in which Boss has a 30 per cent direct project interest.

The key elements of this update include:

- The successful startup of the second Ion Exchange (**IX**) Circuit at the Alta Mesa Central Processing Plant.
- The Processing Plant is running at about 75% of total flow rate designed capacity with the current constraints due to wellfield development.
- enCore is focused on accelerating wellfield development through securing additional drill rig capacity to ensure that wellfield flow rates can be better matched to plant capacity.
- enCore expects the third IX Circuit at the Alta Mesa Central Processing Plant to be online in 2026.

**Boss Managing Director Duncan Craib said:**

*“Sequencing wellfields as part of a ramp-up of new processing circuits, as experienced by our operating partners enCore at present on the Alta Mesa Project, is an important phase for in-situ recovery uranium mines. We believe this is a short-term scheduling issue for enCore due to resource constraints such as drill rigs and higher uranium recovery rates from wellfields.*

*“We remain encouraged by enCore’s program of work in addressing these issues.”*

Boss is working with enCore to provide further clarity on the ramp-up profile to achieve the targeted annualised production rate of 1.5 million pounds U<sub>3</sub>O<sub>8</sub>.
