Servcorp Limited (SRV) - Change of Director's Interest

Mr Roderic Holliday-Smith, Non-Executive Director, and Mr Alf Moufarrige, Executive Director, have both notified SRV of a change of their interests in the Company.

The change of interests have arisen by reason of an off-market transfer of shares previously held indirectly by Mr Holliday-Smith in Sidekick No 2 Pty Limited as trustee for the R Holliday-Smith Superannuation Fund. Mr Holliday-Smith is a director of Sidekick No 2 Pty Limited (an indirect interest) and also has a beneficial interest in the R Holliday-Smith Superannuation Fund.

The shares have been purchased by an indirect interest of Mr Moufarrige, Sovori Pty Ltd. Mr Moufarrige is a director of Sovori Pty Ltd.

The transfer was undertaken at the ASX closing price on the day prior to the transfer.
