## ACQUISITION OF FURTHER SHARES IN P-FUEL

Bisan Limited (ASX: BSN) ("the Company") has issued 1,500,000 fully paid ordinary shares at an issue price of 1.5 cents (\$0.015) per share as consideration for the purchase of 375,000 fully paid ordinary shares in P-Fuel Limited ("P-Fuel").

The Company is the largest single shareholder of P-Fuel with a 16.4% stake.
