## **Successful Completion of US\$4 million Private Placement**

---

Theta Gold Mines Limited ("**Theta Gold**" or the "**Company**") (ASX:TGM) refers to its ASX announcement dated 26 June 2024<sup>1</sup> with regards to an additional Private Placement for US\$4 million (~AU\$6.02<sup>2</sup> million) before costs.

Following the approval of resolutions 15 and 16 by shareholders at a General Meeting held on 28 October 2024, the Company has issued 46,276,113 new TGM fully paid Ordinary Shares at the issue price of \$0.13 (13 cents per share) and granted 23,138,057 unlisted attaching options on 31 October 2024 to sophisticated and professional investors on the same terms as those applied in the two-tranche Placement announced on 11 June 2024<sup>3</sup>.

Each Placement Option will have an exercise price equal to an 8% discount to the 15-day VWAP to the last closing price at the time of exercise (but no less than \$0.13 cents), and expiry date 2 years from the date of issue. Options issued under the Placement will not be quoted.

Both the issue of new Shares and the granting of new Options have been done so following shareholder approvals and therefore will not utilise the Company's existing placement capacity available under Listing Rules 7.1.

The new shares issued will rank equally with existing fully paid ordinary shares of Theta Gold.

This placement was arranged by Golden Asia Investment Group Limited out of Hong Kong who acted as Lead Manager.

## ABOUT THETA GOLD MINES LIMITED

Theta Gold Mines Limited (ASX:TGM) is a gold development company that holds a range of prospective gold assets in a world-renowned South African gold mining region. These assets include several surface and near-surface high-grade gold projects which provide cost advantages relative to other gold producers in the region.

Theta Gold's core project is located next to the historical gold mining town of Pilgrim's Rest, in Mpumalanga Province, some 370km northeast of Johannesburg by road or 95km north of Nelspruit (Capital City of Mpumalanga Province). Following small scale production from 2011 – 2015, the Company is currently focussing on the construction and financing of a new gold processing plant within its approved footprint at the TGME plant.

The company has completed a Feasibility Study (FS) released to ASX on 27 July 2022, for the first four mines Beta, CDM, Frankfort and Rietfontein (TGME Underground Project). The Base Case LOM plan comprises a 12.9-year mining operation starting in 2023 and delivering production of 1.24 million ounces of contained gold.

The estimated development capital or peak funding requirement is USD77 million (AUD102 million), with the Project forecast to generate a pre-tax NPV10% of USD324 million (AUD432 million) and pre-tax Internal Rate of Return (IRR) of 65% at the forecast gold price of averaging USD1,642/oz over the LOM.

The Company aims to build a solid production platform to over next 5 years to 160kozpa based primarily around shallow, open-pit or adit-entry shallow underground hard rock mining sources. Theta Gold has access to over 43 historical mines and prospect areas that can be accessed and explored, with over 6.7Moz of historical production recorded.

Theta Gold holds 100% issued capital of its South African subsidiary, Theta Gold SA (Pty) Ltd ("TGSA"). TGSA holds a 74% shareholding in both Transvaal Gold Mining Estates Limited ("TGME") and Sabie Mines (Pty) Ltd ("Sabie Mines"). The balance of shareholding is held by Black Economic Empowerment

("BEE") entities. The South African Mining Charter requires a minimum of 26% meaningful economic participation by the historically disadvantaged South Africans ("HDSAs"). The BEE shareholding in TGME and Sabie Mines is comprised of a combination of local community trusts, an employee trust and a strategic entrepreneurial partner.
