	Yes. The Company is expecting receipt of more than \$1.2m in Research and Development tax credits (as part of its FY2023 Income Tax Return) in the current quarter (January – March 2024) as well as additional revenue inflows and the exercise of options prior to the end of June 2024.

Yes. As noted above, the Company anticipates the receipt of more than \$1.2m in Research and Development tax credits in the current quarter, additional revenue inflows and the exercise of options prior to the end of June 2024 which will provide adequate near-term funding for the Company to continue its operations and meet its business objectives.
