	Answer: No. The Company was in a growth phase which was impeded by a work place accident and plant closure for most of the quarter. The Company was able to sustain its sales position from stock, however its major plant has recommenced operation and additional orders have been secured. The Company anticipates a recommencement of its growth path with the generation of positive cashflows from operations.

	Answer: No. However the Company continues to review opportunities to create shareholder value and in that context may seek raise funds in support of this.

Answer: Yes. The Company has demonstrated a pathway to profitability with ongoing and increasing product demand and has yet to exploit all the opportunities available within its current operations.
