**SECONDARY TRADING NOTICE PURSUANT TO SECTION 708A(5) OF THE CORPORATIONS ACT 2001 (“Act”)**

On 4 October 2017, Blackham Resources Limited (“**the Company**”) issued a total of 6,703,911 fully paid ordinary shares in the capital of the Company which were issued by the Company pursuant to the entering into of a Share Purchase Agreement.

    - ii. The rights and liabilities attaching to the Shares.
