Issue of Highline Shares, Section 708A Cleansing Notice and Appendix 3B

Auctus Alternative Investments Limited [ASX:AVC] (**Auctus or the Company**) advises that it has today issued 750,000 in relation to achievement of the first milestone shares with respect to the acquisition of High Line Alternative Investments Pty Ltd.

On 2 February 2018, the Company announced that it had been granted a waiver from ASX with respect to the issue of deferred consideration with the Milestone 1 shares being issued by no later than 31 December 2018.

Section 708A Cleansing Notice

This notice is given by Auctus Alternative Investments Limited (**Company**) under Section 708A(5)(e) of the Corporations Act 2001 (Cth) (Corporations Act).

The Company hereby confirms that:

- a) It has issued a total of 2,089,575 fully paid ordinary shares (Shares) issued as follows:
 - i. 1,005,575 fully paid ordinary shares issued at an issue price of \$0.46 per share;
 - ii. 750,000 subject to a 12 month voluntary escrow, in relation to the Highline Alternative Investments Pty Ltd acquisition;

- c) The Company is providing this notice under section 708A(5)(e) of the Corporations Act;
