	<p>Answer: No. Due to the seasonality of fashion purchasing it is common for the women's clothing retail sector at the end of each of the March and September quarters to deliver net cash outflows and the December and June Quarters to deliver net cash inflows.</p>

	<p>Answer: In the December quarter Mosaic completed the \$32 million capital raise process via convertible notes, in addition securing a new \$59 million credit facility with the Commonwealth Bank.</p>
