Information required under ASX Listing Rule 3.10.5A

Sovereign Metals Limited (“the Company”) has today issued 30,000,000 fully paid ordinary shares under the Company’s capacity under Listing Rules 7.1 and 7.1A. The information required under ASX Listing Rule 3.10.5A is set out below:

- (a) Dilution to existing shareholders as a result of the issue under Listing Rule 7.1A is 9.1%, dilution to existing shareholders as a result of the issue under Listing Rule 7.1 is 10% and the total dilution to existing shareholders is 17.4%. The securities issued under Listing Rule 7.1A have been issued to both existing and new security holders. The percentage of the post-placement capital is as follows:
- 77.28% held by pre-placement security holders who did not participate in the placement;
 - 9.56% held by pre-placement security holders who did participate in the placement (incl. 8.17% held by those who participated under Listing Rule 7.1A); and
 - 13.16% held by participants in the placement who were not previously security holders (incl. 4.68% held by those who participated under Listing Rule 7.1A).
- (b) Sovereign has issued 14,242,013 placement shares under Listing Rule 7.1A as a placement was considered to be a more efficient mechanism for raising funds. The placement did not expose the Company to additional costs, a protracted process and market volatility that may have been experienced with a pro-rata issue or other type of issue in which existing ordinary security holders would have been eligible to participate;
- (c) No underwriting arrangements are in place for the placement under rule 7.1A; and
- (d) A fee of up to 5% may be paid to eligible brokers in connection with the placement under rule 7.1A.
