APPENDIX 5B – EXPLANATION OF NEW FORMAT VARIATIONS

Lithium Power International Limited (ASX: LPI) (“LPI” or “the Company”) advises that attached is the **Appendix 5B – Mining exploration entity or oil and gas exploration entity quarterly cash flow report (“5B”)** for the quarter ended 31 March 2020.

ASX released a new formatted 5B for use from calendar year 2020, with some slight variations to the previous format. The following line items have been amended in their treatment in the 5B relating to the expensing and/or capitalisation of Exploration Evaluation expenses. Therefore, to be consistent in its treatment of these line items in the 5B, the Company has re-categorised the Year-to-Date balances as per below:

Line item 1.2(a) - Exploration & Evaluation (if expensed), (“E&E”) expenses.

These expenses will not be capitalised in the Company’s financial statements. Previously all E&E’s were disclosed on this line within the 5B and then capitalised in the annual financial statements.

Line item 2.1(d) - Exploration & Evaluation (if capitalised), (“E&E”) expenses

These expenses will be capitalised in the Company annual financial statements. This line item includes the Company’s capital contribution to the MSB Chilean Joint venture, which was previously classified as 2.1(f) – other non-current assets.

Also included in this Line 2.1(d) is the capitalisation of Western Australia exploration costs. As above, these were previously included in Line item 1.2(a), and capitalised on an annual basis within the Company’s annual financial statements.

All future lodgments of the 5B will follow this new 5B format and associated reporting guidelines.
