19th September, 2016 - The Directors of Emefcy are pleased to announce that the official inauguration of the Company's first commercial municipal scale MABR-based wastewater treatment plant took place at a public ceremony in HaYogev, Israel on 15th September.

The ribbon cutting ceremony was attended by a number of VIP guests from Israel, Australia, well respected news media, as well as Emefcy Board members from the US, Israel and Australia. The dedication ceremony speakers included Mr Tzachi Wermus, CEO of Yuvali HaEmek municipality; Professor Avner Adin – Chairman of Adin Holdings, a globally recognised end to end water solutions firm; Mr Richard Irving, Executive Chairman of Emefcy; and Managing Director, Mr Eytan Levy.

Mr Wermus articulated his clear enthusiasm for Emefcy's MABR solution which, for the first time, enables the community of HaYogev the benefit of state of the art treatment of their waste water with very low energy operating costs, as well as the supply of ample treated water for their agricultural irrigation needs. He further commented about Emefcy's project having a range of unmatched key benefits, including lower commissioning costs, superior environmental performance, lower ongoing operating costs than its competitors, as well as being neighbourhood friendly and built from long life components.

The new municipal MABR facility serves the rural farming community of 1,000 homes, agricultural fields as well as local dairy needs. Its demographics are representative of hundreds of thousands of rural communities worldwide, especially in China, where under the current 13th 5 Year plan, more than 110,000 such "off-grid" communities are currently seeking wastewater treatment solutions.

Mr Richard Irving, Emefcy Executive Chairman, noted that the flawless commissioning of the HaYogev municipal plant represents a key milestone for the company as it continues to grow, with Emefcy MABR based wastewater treatment plants currently under construction on the US Virgin Island of St. Thomas, a larger plant with 3 times the treatment capacity of HaYogev at Mekele University Hospital in Ethiopia, and in Jiangsu Province China. At the ceremony, Mr Levy thanked the dedication of the Emefcy team and shared the company's vision for being the leading solution provider of energy efficient, cost effective wastewater treatment plants worldwide.
