## **QUARTERLY ACTIVITIES REPORT – 3 MONTHS ENDED 30 JUNE 2022**

Ikwezi Mining Limited (**ASX: IKW, Ikwezi Mining or Company**).

### **Operational update**

Mining and Wash Plant operations were severely impacted during the current quarter due to flooding in the KwaZulu-Natal Province, this resulted in a 37% decrease in Run-of- Mine (ROM) production from the Kliprand pit and significant decrease in production for the Emoyeni Wash Plant compared to previous quarter figures.

The first coal was produced from the Goedeheop pit in May as per expectation. A total of 90,614 tonnes was produced during the quarter from the pit.

The Company has been facing challenges at its Emoyeni Wash Plant due to reduced plant availability.

### **Finance update**

Cash and cash equivalents of the Company as at 30 June 2022 amounted to A\$ 1,843 million (31 March 2022: A\$ 3,927 million).

No expenditure was incurred on exploration or development activities during the quarter. The expenditure of A\$ 15,957 million was incurred on mining production activities during the quarter.

### **Future Developments**

The Company plans to improve plant availability at its Emoyeni Wash Plant through maintenance upgrades to achieve planned production targets in the coming quarters.

## Summary

Key management focus in the short term remains on increasing production and improving the product value through beneficiation of the coal at the Emoyeni wash plant.

The Company's Appendix 5B, item 6.1 and 6.2 includes payments made to Zarbon Ngagane (Pty) Ltd and Zarbon Coal (Pty) Ltd (related parties) for fees charged relating to the transportation of coal and purchase of mining machinery respectively.

*Ikwezi Mining Limited is focused on the exploration and development of coal projects in South Africa. The Ikwezi mining right area consists of a number of opencast and underground areas. The Kliprand Colliery (previously, Ntendeka) is the initial opencast area where mining operations have commenced. Ikwezi has a 70% stake in the mining right area located in the province of KwaZulu-Natal and are in close proximity to rail and port infrastructure.*
