

QUARTERLY ACTIVITIES REPORT THREE MONTHS to 30 SEPTEMBER 2015

Key activities undertaken by the company in the September 2015 quarter included:

- On 20 July 2015, Bandanna Energy Limited (Administrators Appointed) announced that the Commonwealth Government has issued its approval permit pursuant to the Environmental Protection and Biodiversity Conservation Act (EPBC Act) for the South Galilee Coal Project (Project).

The Project and MLA 70453, is owned by the South Galilee Coal Joint Venture, which is made up of Bandanna Energy Limited (50%) and AMCI (Alpha) Pty Ltd (AMCI) (50%). AMCI is the Manager and Marketing Agent for the Joint Venture.

That permit, which covers the mine area as well as the infrastructure corridor and rail loadout, confirms the authority for the project to proceed under the provisions of the EPBC Act and provides conditions under which the project must be developed and operated. The Joint Venture has confirmed to the Commonwealth Government that it is satisfied with all the conditions that are included in the permit.

The Environmental Impact Statement for the project was also approved by the Queensland Government in December 2014.


The permit from the Commonwealth Government now secures both State and Commonwealth approval for both the South Galilee and Springsure Creek Coal Projects and confirms the advanced nature of Bandanna Energy's major assets.

- Upon the application of the Administrators, on 30 September 2015, the Supreme Court of Queensland, granted an extension to the convening period to 25 March 2016 to call the second meeting of creditors of Bandanna Energy Limited (Administrators Appointed) and the following subsidiaries:
