	<p>Impact of COVID-19 pandemic is still being felt throughout the commercial real estate industry. However, the board and the management has continued to focus on its existing pipeline and collection of receivables. The board and management emphasise at this time BuildingIQ cannot make accurate forecasts and any assumptions about the future prospects are likely to be erroneous. Further due to the appointment of the Receivers and Managers over certain assets (namely the bank accounts and accounts receivable) of one subsidiary and liquidation of another subsidiary have impacted BuildingIQ adversely, and the management is currently assessing its potential impact on the company's operations and overall cash flow.</p>

SNAPS continues to fund BuildingIQ operational shortfall. SNAPS will continue to follow the discretionary terms and conditions outlined in its agreement with BuildingIQ.
