## VOTING IN PERSON

---

To vote in person, attend the Annual General Meeting on the date and at the place set out on page 4.

## APPOINTING A PROXY

---

A Shareholder who is entitled to attend and vote at the Meeting may appoint a proxy to attend and vote at the Meeting on their behalf. A proxy does not need to be a Shareholder of the Company.

If a Shareholder is entitled to cast two or more votes at the Meeting, the Shareholder may appoint two proxies and may specify the percentage or number of votes each proxy can exercise. ## **Voting Prohibition and Voting Exclusion Statements**

For the definitions of Key Management Personnel (**KMP**) and Closely Related Parties, please refer to the Glossary on page 29.

The Corporations Act restricts members of the KMP of the Company and their Closely Related Parties from voting in relation to remuneration related Resolutions (such as Resolutions 1, 5, 6 and 7), voting prohibitions.

In addition, separate voting restrictions apply in respect of Resolutions 5, 6, 7, 8, 9 and 10 under the ASX Listing Rules, voting exclusions.

**What this means for Shareholders:** If you intend to appoint a member of the KMP (other than the Chairman of the Meeting) as your proxy, please ensure that you direct them how to vote on Resolutions 1, 5, 6 and 7. If you do not do so, your proxy will not be able to vote on your behalf on Resolutions 1, 5, 6 and 7.

If you intend to appoint the Chairman of the Meeting as your proxy, you are encouraged to direct him how to vote by marking the boxes for Resolutions 1, 5, 6 and 7 (for example if you wish to vote for, or against, or to abstain from voting). If you appoint the Chairman as your proxy without directing him how to vote, the Proxy Form authorises him to vote as he decides on Resolutions 1, 5, 6 and 7 (even though those Resolutions are connected with the remuneration of KMP). The Chairman of the Meeting intends to vote in favour of all Resolutions (where permissible).

The Company will disregard votes cast on Resolutions 1, 5, 6, 7, 8, 9 and 10 by the persons detailed in the below.

### **Resolution 1 – Adoption of Remuneration Report**

#### **Voting Prohibition Statement:**

In accordance with the Corporations Act, a vote on Resolution 1 must not be cast (in any capacity) by or on behalf of any of the following persons:

- (a) a member of the KMP, details of whose remuneration are included in the Remuneration Report for the year ended 30 June 2017; and
- (b) Closely Related Parties of such a member.

However, a person described above may cast a vote on Resolution 1 as a proxy if the vote is not cast on behalf of a person described above and either:

- (a) the person does so as a proxy appointed by writing that specifies how the proxy is to vote on Resolution 1; or
- (b) the person is the Chairman of the Meeting and the appointment of the Chairman as proxy:
  - i. does not specify the way the proxy is to vote on Resolution 1; and
  - ii. expressly authorises the Chairman to exercise the proxy even though Resolution 1 is connected directly or indirectly with the remuneration of a member of the KMP.

### **Resolutions 5, 6 and 7 – Grant of Options to Directors**

#### **Voting Prohibition Statement:**

In accordance with the Corporations Act, a person appointed as proxy must not vote on Resolutions 5, 6 and 7 on the basis of that appointment, if that person is:

- (a) a member of the KMP as at the date of the Meeting; or
- (b) Closely Related Parties of such a member.



However, a person described above may cast a vote on Resolutions 5, 6 and 7 if the person does so as a proxy for a person who is entitled to vote where:

- (a) the Proxy Form specifies how the proxy is to vote on Resolutions 5, 6 and 7; or
- (b) the proxy is the Chairman of the Meeting, who may vote in favour of Resolutions 5, 6 and 7 in accordance with an express authorisation on the Proxy Form.

In addition, a vote on Resolutions 5, 6 and 7 must not be cast (in any capacity) by or on behalf of Mr Pocock or Mr Goldsmith or Mr Walsh (in respect of their relevant Resolutions) or any of their associates. However, this prohibition does not apply if:

- (a) the vote is cast by a person as proxy and the proxy form specifies how the proxy is to vote on Resolutions 5, 6 and 7; and
- (b) the vote is not cast on behalf of Mr Pocock or Mr Goldsmith or Mr Walsh (as appropriate), their associates or any related party of them.

**Voting Exclusion Statement:**

The Company will disregard any votes cast on Resolutions 5, 6 and 7 by or on behalf of a Director and an associate of a Director (except a Director who is ineligible to participate in any employee incentive scheme of the Company or any associate of such Director), as required by ASX Listing Rule 10.14.

However, the Company need not disregard a vote cast if:

- (a) it is cast by a person as proxy for a person who is entitled to vote, in accordance with the directions on the Proxy Form; or
- (b) it is cast by the Chairman of the Meeting as proxy for a person who is entitled to vote, in accordance with a direction on the Proxy Form to vote as the proxy decides.

**Resolution 8 – Ratification of Prior Issue of Securities, Placement to Mineral Resources Limited**

**Voting Exclusion Statement:**

The Company will disregard any votes cast on Resolution 8 by or on behalf of any person who participated in the relevant share issue the subject of Resolution 8 and any of their associates.

However, the Company need not disregard a vote cast if:

- (a) it is cast by a person as proxy for a person who is entitled to vote, in accordance with the directions on the Proxy Form; or
- (b) it is cast by the Chairman of the Meeting as proxy for a person who is entitled to vote, in accordance with a direction on the Proxy Form to vote as the proxy decides.

**Resolution 9 – Ratification of Prior Issue of Securities**

**Voting Exclusion Statement:**

The Company will disregard any votes cast on Resolution 9 by or on behalf of any person who participated in the relevant share issue the subject of Resolution 9 and any of their associates.

However, the Company need not disregard a vote cast if:

- (a) it is cast by a person as proxy for a person who is entitled to vote, in accordance with the directions on the Proxy Form; or
- (b) it is cast by the Chairman of the Meeting as proxy for a person who is entitled to vote, in accordance with a direction on the Proxy Form to vote as the proxy decides.

## **Resolution 10 – Approval of 10% Placement Capacity**

### **Voting Exclusion Statement:**

The Company will disregard any votes cast on Resolution 10 by any person who may participate in the issue of Equity Securities under this Resolution and a person who might obtain a benefit, except a benefit solely in the capacity of a holder of ordinary securities, if Resolution 10 is passed, and any associates of those persons.

## EXPLANATORY STATEMENT

This Explanatory Statement has been prepared for the information of the Shareholders of the Company in connection with the business to be conducted at the Annual General Meeting to be held on Wednesday, 22 November 2017 at 9.30am (AWST).

This purpose of this Explanatory Statement is to provide information which the Directors believe to be material to Shareholders in deciding whether or not to pass the Resolutions in the Notice of Meeting.

---

### 1. ANNUAL REPORT

The business of the Meeting will include receipt and consideration of the Company's Annual Financial Report, the Directors' Report and the Auditor's Report for the year ended 30 June 2017, which are included in Hazer's Annual Report.

In accordance with the Corporations Act 2001, Shareholders will be given a reasonable opportunity at the Annual General Meeting to ask questions and make comments on the Annual Report, and on the management of Hazer.

The Company's auditor will be present at the Meeting. During the discussion of this item, the auditor will be available to answer questions on:

- the conduct of the audit;
- the preparation and content of the Auditor's Report;
- the accounting policies adopted by the Company in relation to the preparation of the Financial Statements; and
- the independence of the auditor in relation to the conduct of the audit.

#### Written questions for the auditor

If you would like to submit a written question about the content of the Auditor's Report or the conduct of the audit of the Annual Financial Report to the Company's auditor, please send your question to the Company Secretary. A list of qualifying questions will be made available at the Meeting.

Please note that all written questions must be received at least five business days before the Meeting, that is by Wednesday, 15 November 2017.

### 2. RESOLUTION 1 – ADOPTION OF REMUNERATION REPORT

The Remuneration Report is set out in the Annual Report. The Remuneration Report details the Company's remuneration arrangements for the Directors and senior management of the Company.

S250R(2) of the Corporations Act requires that a resolution to adopt the Remuneration Report be put to the vote of the Company. Shareholders should note that the vote on Resolution 1 is advisory only and not binding on the Company or its Directors.

However, under the Corporations Act, if at least 25% of the votes cast on Resolution 1 are against the adoption of the Remuneration Report then:

- if comments are made on the Remuneration Report at the Meeting, Hazer's 2018 Remuneration Report will be required to include an explanation of the Board's

- proposed action in response or, if no action is proposed, the Board's reasons for this; and
- if, at next year's AGM, at least 25% of the votes cast on the resolution for adoption of the 2018 Remuneration Report are against it, Hazer will be required to put to Shareholders a resolution proposing that an Extraordinary General Meeting (**EGM**) be called to consider the election of Directors (**Spill Resolution**). If the Spill Resolution is passed (i.e. more than 50% of the votes cast are in favour of it), all of the Directors (other than the Managing Director) will cease to hold office at the subsequent EGM, unless re-elected at that Meeting.

In accordance with the Corporations Act, Shareholders will be given a reasonable opportunity at the Annual General Meeting to ask questions and make comments on the Remuneration Report.

**Board recommendation:** *The Remuneration Report forms part of the Directors' Report, which was approved in accordance with a unanimous resolution of the Board. Each Director recommends that Shareholders vote in favour of adopting the Remuneration Report.*

---

### 3. RE-ELECTION OF DIRECTORS

#### Constitution

Clause 7.2(b) of the Constitution provides that the Directors may at any time appoint a person to be a Director. Clause 7.3(f) of the Constitution requires that any Director appointed under clause 7.2(b) holds office only until the next following annual general meeting, and is then eligible for re-election.

Clause 7.3(a) of the Constitution requires that one third of the Directors (excluding Directors appointed under clause 7.2(b)), or if their number is not a multiple of three, then the whole number nearest one third, must retire at each annual general meeting. It also provides that a Director who retires under clause 7.3(a) is eligible for re-election. Clause 7.3(e) of the Constitution provides that the Managing Director is exempt from this requirement.

#### RESOLUTION 2 – RE-ELECTION OF TIM GOLDSMITH

Tim Goldsmith seeks re-election in accordance with clause 7.3(f) of the Constitution.

## 4. GRANTS OF OPTIONS TO DIRECTORS

### **Background**

It is proposed to issue Options to the following Directors of the Company Geoff Pocock (Managing Director), Tim Goldsmith (Non-Executive Chairman) and Terry Walsh (Non-Executive Director).

### **ASX Listing Rule 10.11**

ASX Listing Rule 10.11 states that an entity must not issue or agree to issue equity securities to any of the following persons without first receiving Shareholder approval:

- (a) a related party; or
- (b) a person whose relationship with the entity or a related party is, in the ASX's opinion, such that approval should be obtained.

A 'related party' for the purposes of the Corporations Act includes:

- (a) a director of a public company; and

- (b) an entity controlled by a director of a public company.

Accordingly Geoff Pocock, Tim Goldsmith and Terry Walsh are each a “related party” of the Company.

#### **Chapter 2E of the Corporations Act**

Chapter 2E of the Corporations Act prohibits a public company from giving a financial benefit to a related party of a public company unless the benefit falls within one of various exceptions to the general prohibition. Exceptions to this general prohibition include where the company first obtains the approval of its shareholder in general meeting, or the financial benefit being provided is on arm’s length terms or better.

A “financial benefit” for the purposes of the Corporations Act includes issuing securities to a related party.

#### **RESOLUTION 5 – GRANT OF OPTIONS TO GEOFF POCOCK, MANAGING DIRECTOR**

##### **Shareholder approval**

For the purposes of ASX Listing Rule 10.13, the following information is provided to Shareholders:

- (a) The Options will be issued to Geoff Pocock or to his nominee.
- (b) The maximum number of Options that will be issued to Geoff Pocock or to his nominee is 3,250,000.

- (f) A voting exclusion applies to this item of business, as set out in the Notice of Meeting.
- (g) There will be no funds raised by the issue of the Options. Any proceeds received by the Company from the exercise of the Options will be used to provide additional working capital to the Company.

For the purposes of Part 2E.1 of the Corporations Act, the additional disclosures in Annexure 1 are made.

These Options are proposed to be issued to Tim Goldsmith as part of his total Director remuneration package, where the Company seeks to conserve its cash reserves as best possible, whilst retaining the services of highly qualified and experienced personnel.

For the purposes of ASX Listing Rule 10.13, the following information is provided to Shareholders:

- (h) The Options will be issued to Tim Goldsmith or to his nominee.
- (i) The maximum number of Options that will be issued to Tim Goldsmith or to his nominee is 3,750,000.
- (j) The Company proposes to issue the Options to Tim Goldsmith on 24 November 2017, but in any case no later than one month after the date of the Meeting.
- (k) Tim Goldsmith is a Director of the Company.
- (l) The Options will be issued for no cash consideration. 1,000,000 Options will have an exercise price of \$0.75 and an expiry date of 30 June 2020 (Series G Options) vesting 6 months from 24 July 2017 provided that the holder has continued to be engaged as a Director and employee of the Company prior to and at the vesting date, 1,250,000 Options will have an exercise price of \$0.95 and an expiry date of 31 December 2020 (Series J Options) vesting 12 months from the 24 July 2017 provided that the holder has continued to be engaged as a Director and employee of the Company prior to and at the



vesting date and 1,500,000 Options will have an exercise price of \$1.20 and an expiry date of 31 December 2021 vesting 18 months from 24 July 2017 provided that the holder has continued to be engaged as a Director and employee of the Company prior to and at the vesting date. - (m) A voting exclusion applies to this item of business, as set out in the Notice of Meeting.
- (n) There will be no funds raised by the issue of the Options. Any proceeds received by the Company from the exercise of the Options will be used to provide additional working capital to the Company.

For the purposes of Part 2E.1 of the Corporations Act, the additional disclosures in Annexure 1 are made.

**Board recommendation:** *The Directors (with Tim Goldsmith abstaining) unanimously recommend that Shareholders vote in favour of approving the grant of Options to Tim Goldsmith.*

These Options are proposed to be issued to Terry Walsh as part of his total Director remuneration package, where the Company seeks to conserve its cash reserves as best possible, whilst retaining the services of highly qualified and experienced personnel.

For the purposes of ASX Listing Rule 10.13, the following information is provided to Shareholders:

- (o) The Options will be issued to Terry Walsh or to his nominee.
- (p) The maximum number of Options that will be issued to Terry Walsh or to his nominee is 450,000.
- (q) The Company proposes to issue the Options to Terry Walsh on 24 November 2017, but in any case no later than one month after the date of the Meeting.
- (r) Terry Walsh is a Director of the Company.
- (s) The Options will be issued for no cash consideration. 450,000 Options will have an exercise price of \$0.75 and an expiry date of 30 June 2020 (Series G Options) and are fully vested and 450,000 Options will have an exercise price of \$0.90 and an expiry date of 31 December 2020 (Series I Options) vesting on 7 August 2018 provided that the holder has continued to be engaged as a

Director and employee of the Company prior to and at the vesting date. Other material terms and conditions of the Options are set out at Schedule 1.

- (t) A voting exclusion applies to this item of business, as set out in the Notice of Meeting.
- (u) There will be no funds raised by the issue of the Options. Any proceeds received by the Company from the exercise of the Options will be used to provide additional working capital to the Company.

For the purposes of Part 2E.1 of the Corporations Act, the additional disclosures in Annexure 1 are made.

**Board recommendation:** *The Directors (with Terry Walsh abstaining) unanimously recommend that Shareholders vote in favour of approving the grant of Options to Terry Walsh.*

*The Directors do not consider that from an economic and commercial point of view, there are any costs or detriments, including opportunity costs or taxation consequences for the Company or benefits foregone by the Company in issuing the Options.*

## 5. RATIFICATION OF PRIOR ISSUE OF SECURITIES

### Background

The Company has made the following issues of Shares and Options under ASX Listing Rule 7.1:

On 20 March 2017, the Company announced that it had issued (i) 8,333,333 Shares at \$0.60 per share raising \$5.0 million and (ii) 4,166,667 free attaching Series H Options with an exercise price of \$0.70 and expiry date of 31 December 2019, in a strategic placement to Mineral Resources Limited (ASX: MIN).

On 6 September 2017, the Company announced that it had issued 300,000 Series G Options with an exercise price of \$0.75 and an expiry date of 30 June 2020 to a contractor to the Company for nil consideration as compensation for professional services provided to the Company.

### ASX Listing Rule 7.1

ASX Listing Rule 7.1 restricts listed companies in relation to the number of equity securities that they can issue or agree to issue without shareholder approval. Generally, a listed company cannot, in any 12 month period, issue a number of equity securities which is more than 15% of their fully paid ordinary shares on issue without shareholder approval (**15% limit**), unless an exception applies. The Company has not exceeded this 15% limit.

### ASX Listing Rule 7.4

ASX Listing Rule 7.4 provides that where holders of ordinary securities approve a previous issue of securities made without approval under ASX Listing Rule 7.1, and provided that the previous issue of securities did not breach ASX Listing Rule 7.1, those securities shall be deemed to have been issued with Shareholder approval for the purpose of ASX Listing Rule 7.1.

## RESOLUTION 8 – RATIFICATION OF PRIOR ISSUE OF SECURITIES, PLACEMENT TO MINERAL RESOURCES LIMITED

### Shareholder approval

Shareholder approval is now sought for the issue of 8,333,333 Shares and 4,166,667 unlisted Options with an exercise price of \$0.70 and expiry date of 31 December 2019 as set out below, pursuant to ASX Listing Rule 7.4, to reinstate the Company's capacity to issue up to 15% of its ordinary issued capital under ASX Listing Rule 7.1, if required, over a 12 month period without seeking further Shareholder approval.

ASX Listing Rule 7.5 requires the following information to be provided to Shareholders:

- (a) the number of securities issued was 8,333,333 Shares and 4,166,667 Options.
- (b) 8,333,333 Shares were issued at \$0.60 per share raising \$5.0 million and 4,166,667 Options were issued for nil consideration.
- (c) the Shares issued rank equally with, and are on the same terms as, the existing Shares on issue. The terms of the Options issued are as follows:

- (d) The Shares and Options were issued to Mineral Resources Limited (ASX:MIN).
- (e) Funds raised from the issue of 8,333,333 Shares have been and will be used to further the Company's research and development programs and supplement the Company's existing working capital. No funds were raised from the issue of 4,166,667 Options, the funds raised on the exercise of the Options will be used to supplement the Company's existing working capital.
- (f) a voting exclusion applies to this item of business, as set out in the Notice of Meeting.

**Board recommendation:** *The Directors unanimously recommend that Shareholders vote in favour of ratifying the above issue of Equity Securities. This will enable the Company to retain the flexibility to issue further Equity Securities representing up to 15% of the Company's share capital under ASX Listing Rule 7.1 during a 12 month period without seeking further Shareholder approval.*

## RESOLUTION 9 – RATIFICATION OF PRIOR ISSUE OF SECURITIES

### Shareholder approval

Shareholder approval is now sought for the issue 300,000 unlisted Options with an exercise price of \$0.75 and expiry date of 30 June 2020 as set out below, pursuant to ASX Listing Rule 7.4, to reinstate the Company's capacity to issue up to 15% of its ordinary issued capital under ASX Listing Rule 7.1, if required, over a 12 month period without seeking further Shareholder approval.

ASX Listing Rule 7.5 requires the following information to be provided to Shareholders:

- (g) the number of securities issued was 300,000 Options.

- (h) the Options were issued for nil consideration.
- (i) The terms of the Options issued are as follows:

- (j) The Options were issued to a nominee of Mills Resources pursuant to an agreement to provide professional services to the Company.

- (l) a voting exclusion applies to this item of business, as set out in the Notice of Meeting.

**Board recommendation:** *The Directors unanimously recommend that Shareholders vote in favour of ratifying the above issue of Equity Securities. This will enable the Company to retain the flexibility to issue further Equity Securities representing up to 15% of the Company's share capital under ASX Listing Rule 7.1 during a 12 month period without seeking further Shareholder approval.*

---

## 6. RESOLUTION 10 – APPROVAL FOR 10% PLACEMENT CAPACITY

### 10.1 General

Listing Rule 7.1A enables eligible entities to issue Equity Securities totalling up to 10% of its issued share capital through placements over a 12 month period after the entity's annual general meeting (**10% Placement Facility**). The 10% Placement Facility is in addition to the Company's 15% placement capacity under Listing Rule 7.1.

An eligible entity for the purposes of Listing Rule 7.1A is an entity that is not included in the S&P/ASX 300 Index and has a market capitalisation of \$300 million or less. The Company is an eligible entity.

The Company is now seeking Shareholder approval by way of a special resolution to have the ability to issue Equity Securities under the 10% Placement Facility.

The exact number of Equity Securities to be issued under the 10% Placement Facility will be determined in accordance with the formula prescribed in Listing Rule 7.1A.2 (please refer to Section 10.2(c) below).

The Directors believe that Resolution 10 is in the best interests of the Company and unanimously recommend that Shareholders vote in favour of this Resolution.

### 10.2 ASX Listing Rule 7.1A

#### (a) Shareholder approval

The ability to issue Equity Securities under the 10% Placement Facility is subject to shareholder approval by way of a special resolution at an annual general meeting.

Resolution 10 is a special resolution. Accordingly, at least 75% of votes cast by Shareholders present and eligible to vote at the Meeting must be in favour of Resolution 10 for it to be passed.

**(b) Equity Securities**

Any Equity Securities issued under the 10% Placement Facility must be in the same class as an existing quoted class of Equity Securities of the Company.

As at the date of the Notice, the Company has two quoted classes of Equity Securities on issue on the ASX, being the Shares (ASX Code: HZR) and listed Options (ASX Code: HZRO).

**(c) Formula for calculating 10% Placement Capacity**

The exact number of Equity Securities that the Company may issue under an approval under ASX Listing Rule 7.1A will be calculated according to the following formula:

$$(A \times D) - E$$

Where:

A is the number of Shares on issue 12 months before the date of issue or agreement:

- (A) plus the number of Shares issued in the previous 12 months under an exception in ASX Listing Rule 7.2;
- (B) plus the number of partly paid shares that became fully paid in the previous 12 months;
- (C) plus the number of Shares issued in the previous 12 months with approval of holders of Shares under ASX Listing Rule 7.1 or 7.4. This does not include an issue of Shares under the Company's 15% placement capacity without Shareholder approval; and
- (D) less the number of Shares cancelled in the previous 12 months.

Note that A has the same meaning in ASX Listing Rule 7.1 when calculating the Company's 15% placement capacity.

D is 10%.

E is the number of Equity Securities issued or agreed to be issued under ASX Listing Rule 7.1A.2 in the 12 months before the date of issue or agreement to issue that are not issued with the approval of holders of Ordinary Securities under ASX Listing Rule 7.1 or 7.4.

**10.3 Technical information required by ASX Listing Rule 7.3A**

Pursuant to and in accordance with ASX Listing Rule 7.3A, the information below is provided in relation to this Resolution 10.

**(a) Minimum Price**

The minimum price at which the Equity Securities may be issued is 75% of the volume weighted average price of Equity Securities in that class, calculated over the 15 ASX trading days on which trades in that class were recorded immediately before:

- (i) the date on which the price at which the Equity Securities are to be issued is agreed; or
- (ii) if the Equity Securities are not issued within 5 ASX trading days of the date in paragraph (i) above, the date on which the Equity Securities are issued.

**(b) Date of Issue**

The Equity Securities may be issued under the 10% Placement Capacity commencing on the date of the Meeting and expiring on the first to occur of the following:

- (i) 12 months after the date of this Meeting; and
- (ii) the date of approval by Shareholders of any transaction under ASX Listing Rules 11.1.2 (a significant change to the nature or scale of the Company's activities) or 11.2 (disposal of the Company's main undertaking after which date, an approval under Listing Rule 7.1A ceases to be valid),

**(10% Placement Capacity Period).**

**(c) Risk of voting dilution**

Any issue of Equity Securities under the 10% Placement Capacity will dilute the interests of Shareholders who do not receive any Shares under the issue.

If Resolution 10 is approved by Shareholders and the Company issues the maximum number of Equity Securities available under the 10% Placement Capacity, the economic and voting dilution of existing Shares would be as shown in the table below. The table below shows the dilution of existing Shareholders calculated in accordance with the formula outlined in ASX Listing Rule 7.1A.2, on the basis of the current market price of Shares and the current number of Equity Securities on issue as at the date of this Notice.

The table also shows the voting dilution impact where the number of Shares on issue (Variable A in the formula) changes and the economic dilution where there are changes in the issue price of Shares issued under the 10% Placement Capacity.

5. The calculations above do not show the dilution that any one particular Shareholder will be subject to. All Shareholders should consider the dilution caused to their own shareholding depending on their specific circumstances.
6. This table does not set out any dilution pursuant to approvals under ASX Listing Rule 7.1.
7. The 10% voting dilution reflects the aggregate percentage dilution against the issued share capital at the time of issue. This is why the voting dilution is shown in each example as 10%.
8. The table does not show an example of dilution that may be caused to a particular Shareholder by reason of placements under the 10% Placement Capacity, based on that Shareholder's holding at the date of the Meeting

Shareholders should note that there is a risk that:

- (i) the market price for the Company's Shares may be significantly lower on the issue date than on the date of the Meeting; and
- (ii) the Shares may be issued at a price that is at a discount to the market price for those Shares on the date of issue.

**(d) Purpose of Issue under 10% Placement Capacity**

The Company may seek to issue the Equity Securities under the 10% Placement Facility in order to fund the Company's research and development programs, fees in relation to the Company's intellectual property rights and patent protection, as well as general working capital. The Company may also issue Equity Securities for non-cash consideration, such as

for the acquisition of businesses or investments. If the Company issues Equity Securities for non-cash consideration, the Company will provide a valuation of the non-cash consideration that demonstrates that the deemed issue price of the Equity Securities complies with Listing Rule 7.1A.3. The Company will comply with the disclosure obligations under Listing Rules 7.1A.4 and 3.10.5A upon any issue of Equity Securities.

**(e) Allocation under the 10% Placement Capacity**

The Company's allocation policy for the issue of Equity Securities under the 10% Placement Capacity will be dependent on the prevailing market conditions at the time of the proposed placement(s).

The recipients of the Equity Securities to be issued under the 10% Placement Capacity have not yet been determined. However, the recipients of Equity Securities could consist of current Shareholders or new investors (or both), none of whom will be related parties of the Company.

The Company will determine the recipients at the time of the issue under the 10% Placement Capacity, having regard to the following factors:

- (i) the purpose of the issue;
- (ii) alternative methods for raising funds available to the Company at that time, including, but not limited to, an entitlement issue or other offer where existing Shareholders may participate;
- (iii) the effect of the issue of the Equity Securities on the control of the Company;
- (iv) the circumstances of the Company, including, but not limited to, the financial position and solvency of the Company;
- (v) prevailing market conditions; and
- (vi) advice from corporate, financial and broking advisers (if applicable).

Further, if the Company is successful in acquiring new assets or investments, it is likely that the recipients under the 10% Placement Capacity will be vendors of the new assets or investments.

**(f) Previous Approval under ASX Listing Rule 7.1A**

The Company previously obtained approval under ASX Listing Rule 7.1A at an Annual General Meeting on 15 November 2016.

The Company issued 2,809,286 unlisted Options under ASX Listing Rule 7.1A in the 12 months preceding the Annual General Meeting held on 15 November 2016 which represents 2.5% of the total number of Equity Securities on issue at that date. On 15 November 2016, the Company had 113,132,316 Equity Securities on issue made up of 65,598,516 Shares and 48,533,800 Options.
