The agreed maturity date was extended to 31 December 2021 on 18 July 2019 with all other terms remaining in effect.</p> <p>The current terms of the facility are:</p> <ol style="list-style-type: none"> 1. The interest rate is 12% per annum; 2. Interest is payable quarterly in arrears; and 3. The Conversion Price is 80% of the Volume Weighted Average price ("VWAP") calculated 90 days immediately prior to the Conversion Date*. <p>*The Conversion Date is the date of receipt of a valid Conversion Notice.</p> <p>The Company has a loan agreement with Shanghai Long Sheng Technology Development Co. Limited. On 25 September 2020, additional principal was extended to the Company of \$1,500,000 taking the total principal available to \$4,500,000. All other terms remained the same.</p> <p>The terms of the loan are:</p> <ol style="list-style-type: none"> 1. Principal loan available is \$AU4,500,000; 2. Loan agreement date is 21 June 2018; 3.
