Reminder: Closing Date of Share Purchase Plan Offer

Galan Lithium Limited (ASX: GLN) (**Galan** or **the Company**) wishes to remind all eligible shareholders that the Share Purchase Plan (**SPP**), announced on 16 April 2025 and extended on 15 May 2025 will close on Friday, 6 June 2025.
