UPGRADED PROFIT GUIDANCE**Highlights:**

- The Company expects to deliver circa \$2M EBITDA for H1FY23
- First half performance compares favourably against the prior guidance of \$2.1M EBITDA for the entire FY23
- Robust EBITDA growth attributable to strong sales of Certus® devices and continued growth in the Company's underlying businesses, including ZOLEO
- Positive revenue and earnings momentum expected, on balance, to continue throughout FY23
- Company expects to post revenues of circa \$20M for H1FY23 vs. \$12.5M in the previous corresponding period

Beam Communications Holdings Ltd (ASX: BCC, "Beam" or the "Company") a leading satellite communications company, is pleased to announce that it is expecting to post EBITDA of circa \$2 million in just the first six months of FY23.

The expected result is materially ahead of the previously communicated EBITDA guidance of over \$2.1 million for the full year of FY23.

The H1FY23 EBITDA figure exceeds what the Company delivered for the entire FY22.

Beam is also pleased to confirm the strong momentum experienced in the first half of the current financial year is expected to carry into the second half.

This strong revenue and earnings performance has been driven by sales of the new Certus® device as well as growth within the overall business including royalties from ZOLEO.

This half-year result, which remains subject to audit review, represents further evidence of the growth the business has achieved in recent periods:

"With sales of the new Certus® device and strong sales across the existing business, we are pleased to issue a profit upgrade with the Company already having achieved its FY23 EBITDA forecast in the H1FY23. We are confident this strong sales momentum will continue in 2HY23, which will position Beam for continued success and capacity. We look forward to updating the market with further Company developments."
