TY-25/26 Guidance and Q1-25 Distribution

Dalrymple Bay Infrastructure Limited (ASX:DBI) (DBI or the Company) today announces its forecast Terminal Infrastructure Charge and distribution guidance for TY-25/26,¹ together with its Q1-25 distribution.

Highlights

- Forecast Terminal Infrastructure Charge (**TIC**) applicable at Dalrymple Bay Terminal (**DBT**) for TY-25/26 of ~\$3.72 per tonne,² up ~3.6% on TY-24/25.
- Distribution guidance for TY-25/26 totalling 24.5 cents per stapled security (**cps**) to be paid in quarterly distributions, reflecting a 6.5% uplift on distribution guidance referable to TY-24/25 of 23.0 cps.³
- DBI announces its Q1-25 distribution of 5.875 cps, in line with prior guidance.

Forecast Terminal Infrastructure Charge – TY-25/26

The forecast TIC applicable at DBT for TY-25/26 is ~\$3.72² per tonne. DBIM⁴ levies the TIC on each tonne of contracted capacity at DBT, with the terminal fully contracted on a 100% take-or-pay basis at 84.2Mtpa to 30 June 2028 with evergreen renewal options for customers.

The forecast TY-25/26 TIC comprises:

- **Base TIC:** Indexed annually in line with the Australia all groups Consumer Price Index (**CPI**). The TY-25/26 Base TIC component has increased to \$3.52/t, reflecting a 2.4% increase on TY-24/25;
- **NECAP Charge:** Non-expansory capital expenditure (**NECAP**) at DBT earns a return on invested capital set at the 10 Year Australian Government Bond⁵ rate plus a margin, as well as a return of the invested capital in the form of a depreciation allowance. The expected increase in the NECAP Charge to approximately \$0.20/t for TY-25/26 reflects an additional \$30.4m in NECAP expenditure that will be included in the NECAP asset base from 1 July 2025; and
- **QCA Levy:** A pass through of the Queensland Competition Authority's (**QCA**) costs. The QCA Levy for TY-25/26 is expected to be approximately \$0.00 per tonne.

¹ TY is the TIC year commencing on 1 July and ending on 30 June (i.e. TY-25/26 is 1 July 2025 to 30 June 2026).

² ~\$3.72/t TIC forecast is subject to change due to the final calculation of the risk-free rate for the NECAP Charge component and final confirmation by the Queensland Competition Authority of the QCA fees.

TY-25/26 Distribution Guidance

DBI is also pleased to announce its distribution guidance for the year commencing 1 July 2025 (TY-25/26) totalling 24.5 cps to be paid in quarterly distributions, reflecting a 6.5% increase over TY-24/25 distribution guidance of 23.0 cps.⁷

DBI reaffirms its distribution per security growth target of 3-7% per annum for the foreseeable future, subject to business developments and market conditions. The TY-25/26 distribution guidance remains in line with our distribution policy established on listing of targeting to distribute between 60-80% of Funds from Operations (FFO).⁸

Distributions for TY-25/26 are expected to comprise both payments of dividends and partial repayments of the loan notes which form part of DBI's stapled securities.

Q1-25 Distribution

DBI today announces its Q1-25 distribution of 5.875 cps. The Q1-25 distribution is in line with the Company's previous guidance of delivering total distributions for TY-24/25 of 23.0 cps.

The Q1-25 distribution will have a record date of 27 May 2025 and a payment date of 12 June 2025. The distribution will be paid to securityholders as a partially franked dividend⁹ of 4.064 cps and a partial repayment of the loan notes which are part of DBI's stapled securities of 1.811 cps.
