Quarterly Activities Report**Q1 FY25 headlines:**

- **Challenging market conditions continue in key Asian markets;**
- **Wingara cash position fell as expected during June quarter with inventory purchases and subdued export prices impacting revenues;**
- **Management pursuing transaction opportunities in Agriculture sector**

Wingara AG Limited (ASX: WNR), the owner and operator of value-add, mid-stream assets specialising in the processing, storage and marketing of agriculture produce for export markets, is pleased to provide this quarter's activities report alongside its Appendix 4C (Quarterly Cashflow Report) for the three months ended 30 June 2024 (Q1 FY25).

Commenting on Q1 FY25, Wingara's Managing Director and Chief Executive Officer Marcello Diamante said:

"The quarter's financial performance has largely been below expectation driven by continued pricing pressures eroding the business' margins. Plant capacity has now increased where daily production records have been achieved however, overall production is being limited by a subdued operating environment putting pressure on export prices.

As outlined in the last quarter update, subdued economic activity continues to persist in our key markets of Japan, China and South Korea. A weak Yen against the USD and no significant stimulus measures from China will continue to weigh down on export prices this season. Record high prices for domestic oaten hay, pressure on profit margins and cash generation will continue for the remainder of the calendar year.

Wingara management are actively pursuing market opportunities that suit the Wingara platform."

Current cash and cash equivalents as at 30 June 2024 sit at \$1.738 million with a focus on costs and inventory during this challenging operating environment.

In accordance with ASX Listing Rule 4.7C.3, payments to related parties and their associates outlined in the Company's Appendix 4C for the quarter relate to fees and salaries paid to directors.
