JobKeeper s323DB Notice

The Treasury Laws Amendment (2021 Measures No 2) Act 2021 amended the Corporations Act to impose an obligation on listed entities to give a notice to their market operator(s) that discloses specified information about JobKeeper payments they received (JobKeeper notice). The JobKeeper notice is released to the market. The amendment added sections 323DB and 323DC to the Corporations Act, and those provisions commenced on 14 September 2021.

Accordingly, Ashley Services Group Limited (ASX: ASH), provides the appended notice contained at Appendix 1 in accordance with subsection 323DB (1) of the Corporations Act 2001 (Cth).

JobKeeper played an important role for Ashley Services Group in retaining staff that we would have otherwise needed to terminate or indefinitely stood down without pay, given the downturn experienced in revenues in a number of our smaller entities over these periods due to the COVID-19 pandemic. This retention has played an important role in the strong bounce back we have seen, particularly in our results for the FY21 financial year.
