CLEANSING NOTICE

NOTIFICATION PURSUANT TO SECTION 708A(5)(e) OF THE CORPORATIONS ACT 2001 ("Act")

On 22 May 2019, Myanmar Metals Limited (ASX: MYL) (the "Company") issued 3,223,476 ordinary shares ("Shares") in the capital of the Company.

MYL intends to become a leading regional base metals producer and is well positioned to realise this goal, based on the Tier 1 Bawdwin project resources, world class exploration potential, strategically advantageous project location, management team with experience and depth, highly capable local partners and a strong balance sheet with supportive institutional shareholders.

The company holds a majority 51% participating interest in the Bawdwin Project in joint venture with its two local project partners, Win Myint Mo Industries Co. Ltd. (**WMM**) and EAP Global Mining Co. Ltd. (**EAP**).
