NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT 2001 (CTH)

Botanix Pharmaceuticals Limited (ASX: BOT, **Botanix** or **the Company**) advises it has today issued 4,000,000 new fully paid ordinary shares (**New Shares**) on exercise of 2,000,000 \$0.132, 12 September 2024 unquoted options and 2,000,000 \$0.099, 12 September 2024 unquoted options.

The Company hereby provides notification under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**) of the issue of the New Shares. The Corporations Act restricts the on-sale of securities issued without disclosure unless the sale is exempt under section 708 or 708A of the Corporations Act.  - (ii) sections 674 and 674A of the Corporations Act; and
- (d) as at the date of this Notice, there is no excluded information, within the meanings of section 708A(7) and 708A(8) of the Corporations Act.
