### Scheme of arrangement legally effective

Further to its announcement earlier today (i.e. 20 August 2021), Isentia Group Limited (ASX: ISD) (**Isentia**) is pleased to announce that it has lodged with the Australian Securities and Investments Commission (**ASIC**) the orders made by the Supreme Court of New South Wales (**Court**) approving the proposed scheme of arrangement between Isentia and Isentia shareholders pursuant to which Access Intelligence plc (a company incorporated in England and Wales with company registration number 04799195) will acquire all of the Isentia shares that it does not already own (**Scheme**).

A copy of the Court order is set out in **Annexure A** to this announcement. As a result, the Scheme is now legally effective and it is expected that Isentia shares will be suspended from trading on the ASX from close of trading today.

As announced earlier today, Isentia shareholders (other than Excluded Shareholders (as defined in the scheme booklet dated 19 July 2021 (**Scheme Booklet**))) who are registered as such at 7:00pm on Wednesday, 25 August 2021 (**Scheme Record Date**) will receive Scheme Consideration (as defined in the Scheme Booklet) of \$0.175 cash per Isentia share held by them on the Scheme Record Date. Payment of the Scheme Consideration is expected to be made on Wednesday, 1 September 2021.

Hearing of Originating Process filed 18 June 2021. Second Court hearing.

- Black J grants leave for Access Intelligence PLC and Vuelio Australia Pty Ltd to appear under r 2.13 of the Supreme Court (Corporations) Rules.

Black J makes orders (as amended) in accordance with Short Minutes of Order initialled by him and placed in the file.

**THE COURT ORDERS THAT:**

1 Pursuant to section 411(4)(b) of the Corporations Act 2001 (Cth) (the Act), the scheme of arrangement between Isentia Group Limited ACN 167 541 568 (Isentia) and holders of fully paid ordinary shares in the capital of Isentia (other than the Excluded Shareholders (as defined in the Scheme Implementation Deed dated 15 June 2021)) (Scheme), be approved, as amended by Order 2.

2 Pursuant to section 411(6) of the Act, the Scheme be amended by replacing the definition of "Excluded Shareholder" in Schedule 1 of the Scheme with the words "Excluded Shareholder means Vuelio Australia Pty Ltd ACN 640 911 539".

3 Pursuant to section 411(12) of the Act, Isentia be exempted from compliance with section 411(11) of the Act.

4 These orders be entered forthwith.
