NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

The Directors of Roots Sustainable Agricultural Technologies Limited (ASX: ROO, **Roots** or **Company**) provide a notice for the purposes of section 708A(5)(e) of the Corporations Act 2001.

The Company has issued 1,650,000 Chess Depository Interests (CDIs) as per the attached Appendix 3B. These CDIs above are part of a class of securities quoted on ASX and may be subject to a subsequent offer for sale. The Company issued the CDIs above without a disclosure document to investors under Part 6D.2 of the *Corporations Act 2001* (Cth) (the Act).

As at the date of this notice, the Company has complied with:

- a) the provisions of Chapter 2M of the Act as they apply to the Company; and
- b) section 674 of the Act.

As at the date of this notice, other than as set out below, there is no information to be disclosed which is excluded information (as defined in section 708A(7) of the Corporations Act) that is reasonable for investors and their professional advisers to expect to find in a disclosure document.

The Company is intending to undertake a non-renounceable option entitlement issue on the basis of one (1) Option for every two (2) CDIs held by eligible CDI Holders at an issue price of \$0.04 per Option to raise up to approximately \$1.2 million (before costs) (**Entitlement Issue**). The Company is currently preparing a Prospectus for the Entitlement Issue, which will be lodged with ASIC and ASX in due course.
