## QUARTERLY ACTIVITIES REPORT FOR MARCH 2020 QUARTER

### CORPORATE

On 4 March 2020, RMA Energy Limited ("RMA" or "Company") (ASX:RMT) appointed Mr Peng Li as the Chairman of RMA following the resignation of Mr Ying Liu.

Mr Henko Vos was appointed as Joint Company Secretary of the Company on 31 March 2020. On the same day, the Company advised the market that it was not in a position to lodge the audited financial report for the year ended 31 December 2019 by the reporting deadline of 31 March 2020. The delay was due to the reason that the Company was in the process of finalising the financing of additional working capital, which it continues to do.

The Company note that, under the estimated quarters of funding available as calculated under item 8.7 of the new quarterly activities report (Appendix 5B) (attached below), the Company had sufficient cash for 3.5 quarters. Notwithstanding this, the Company note its available cash balance at 31 March 2020 of only \$14,000. The Company expects to incur similar costs for the next quarter as for the March 2020 quarter, however it also expects it will make a larger number of payments in settling outstanding debts. The Company is in the process of obtaining a further loan advance of \$48,000 from its major shareholder CREC Resources (Aust) Pty Ltd, on terms similar to prior loans. It is anticipated that these funds would be available in early May 2020 and would enable the Company to settle most of its current outstanding creditors. The Board continues its review of the Company's overall position and re-capitalisation strategy and options. This includes, but is not limited to, a review of its current tenements holdings.

RMA continues its efforts to seek and review suitable projects and opportunities for potential investment. The Company will advise the market of any developments as appropriate in this regard.

The Company did not make any payments to related parties during the quarter.
