However, it appears that ASX then duplicated the processing of the lapse of these securities, as the lapse was again recorded in a "Changes To Securities - Additional/Buy Backs" notification issued to Metcash on 8 November 2023. As the lapse has been recorded twice by ASX, Metcash is issuing this form to have the duplicate processing rectified.
