First quarter update and cashflow

Highlights:

- **Cash Receipts from sales in excess of \$308k for the quarter.**
- **Callisto endorsed by Gold Cross.**
- **\$930k in cash held at end of quarter.**

28 October 2022 – IoT solutions company, Constellations Technologies Limited (ASX: CT1) (the “Company” or “Group”) is pleased to provide a summary update on its activities for the quarter ended 30 September 2022.

Sales

During the quarter, the Company continued to receive payments from existing and new customers in excess of \$308k for the quarter, being the Company’s biggest cashflow inflow from Australian based sales to date. Sales are primarily based on SaaS platform licencing of the Company’s MeridianCT Platform (MCT) and development of client specific software applications in connection with MCT.

Constellation will continue to further expand the application of the MCT product via these engagements and trial projects in the areas of life sciences cold storage & workflow, energy efficiency and engineering applications.

During the quarter the Company made headway with the marketing of its cold chain monitoring solution, Callisto. Gold Cross who are owned by The Pharmacy Guild, have endorsed Callisto and will work with the Company over the ensuing months to market Callisto to its 5,000 + members in Australia.

The Callisto solution being offered to Pharmacy Guild members will assist Pharmacies to monitor their drug refrigeration to meet health and safety compliance requirements.

Expenditure & financing activities

The Company continues to operate on a cost efficiency basis. Expenditure was slightly higher than previous quarters due to annual operational and corporate compliance costs.

The Company received its FY21 R&D tax incentive payment during the quarter, adding \$635k to the Company’s cash reserves.

Related party cash payments for the quarter were \$81k and consist of salary related payments for CEO, Kartheek Munigoti; director’s fees to two of the Company’s two non-executive directors and office rental and legal fees paid to entities associated with Mr Nicholson. No cash payments have been made to Mr Malone for his directors fees to date.

The board thanks all shareholders for their continued support and interest in the Company.
