# GOLD RC DRILL PROGRAM COMPLETES AT SALT CREEK

## HIGHLIGHTS

- Completion of 941m drill program focusing on high-priority gold targets across Omnia's Salt Creek Project, north-east of Kalgoorlie.
- Drilling focused on untested gold drill targets identified at Salt Creek Project.
- Gold drill targets were identified following geophysical survey acquisition and independent review of gravity and magnetics datasets<sup>1</sup>.
- The Salt Creek Project covers a total of 223km<sup>2</sup> of land across the Goldfields, in a region that is highly prospective for gold, copper, and nickel.

Omnia Metals Group Ltd ("Omnia" or the "Company") (ASX: OM1) is pleased to announce the completion of a 941m Slim Line Reverse Circulation ("SLRC") drill program focusing on high-priority gold and copper targets across its Salt Creek Project, north-east of Kalgoorlie.

## OMNIA METALS EXECUTIVE CHAIRMAN, PATRICK GLOVAC, SAID:

*"We are pleased to have successfully completed our initial SLRC drill program at the Salt Creek Project, targeting high-priority gold and copper anomalies identified through geophysical datasets and expert interpretation. This program represents an important step in unlocking the exploration potential of Salt Creek, a significantly underexplored asset located in a highly prospective region of Western Australia."*

## GOLD DRILL TARGETS

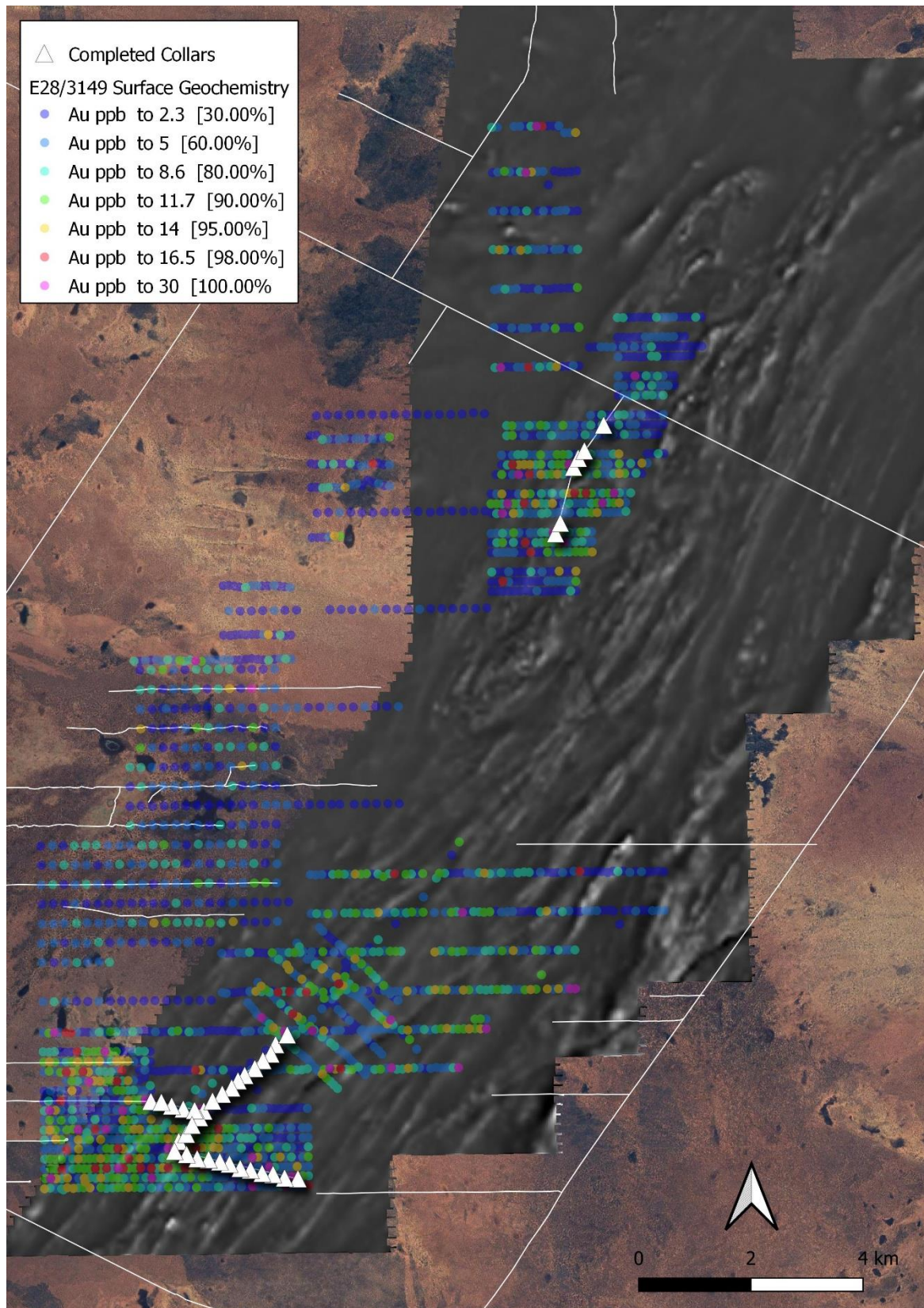


Figure 1: Completed RC Collars at Omnia's Salt Creek Project (EL28/3149)

The SLRC drill program consisted of 39 SLRC drill holes which focussed on untested high-priority gold targets developed from geophysical survey acquisition and independent review of gravity and magnetics datasets (see Figure 1). The data generated from this program will form a strong basis for further work given the lack of previous drilling on the lease targeting gold and copper.
