**SHARE PURCHASE PLAN & PLACEMENT OF OPTIONS FULLY UNDERWRITTEN**

- Zeus Resources is raising approximately \$600,000 via Share Purchase Plan & \$198,169 via Placement of Options
- The Company has engaged GBA Capital Pty Ltd to underwrite both the SPP & Placement of Options

Zeus Resources Ltd (ASX: ZEU, “**Zeus**”, the “**Company**”) announced on 18 October 2024 that it will be undertaking a Share Purchase Plan (“**SPP**”) to raise approximately \$600,000, providing eligible shareholders with the opportunity to subscribe for up to \$30,000 worth of fully paid ordinary shares in the capital of the Company (“**Shares**”) at an issue price of \$0.008 per Share and will include one (1) free attaching option for every two (2) shares subscribed for under the SPP (“**SPP Options**”). In addition, the Company is also proposing to complete a placement of options to holders of “ZEUO” options at \$0.001 per option to raise up to \$198,000 (before costs)<sup>1</sup>.

This SPP & Placement of Options is fully underwritten by GBA Capital Pty Ltd (“**Underwriters**”). The Company has agreed to pay the Underwriters an underwriting fee of 6% of the funds raised under both the SPP & Option Placement. GBA Capital will also receive 15m options on the same terms as the attaching SPP options for being the Lead Manager & Underwriter of the offer (subject to shareholder approval). The underwriter will pay any sub-underwriting fees from this fee.

Funds raised under the SPP and from the proposed issue of the Placement Options will further strengthen the Company’s financial position, facilitate growth and review of new opportunities and will be applied towards due diligence to assess new projects and general working capital requirements and costs of the offers.
