The Company has loan facilities in place with banks in Italy, Israel and Argentina with interest rates varying from 1.7% to 6.6%. The majority of these loan facilities are unsecured. The Company has bank guarantees in place in Italy and Israel. Approximately \$1.2m of these bank guarantees are secured and the interest charges for these bank guarantees vary between 1.5% and 2.5% of the guaranteed amount per year.
