### **Ecologia Engaged for Ocean Hill Environmental Survey**

UIL Energy Ltd (**UIL Energy or the “Company”**) (ASX:UIL) is pleased to announce it has engaged Ecologia Environmental Consultants Pty Limited (Ecologia) for an on-ground environmental assessment required for the planned Ocean Hill 3D seismic program.

UIL Energy is planning the acquisition of 3D seismic data covering up to 250km<sup>2</sup> of Ocean Hill permit EP495. The on-ground environmental (flora/fauna) assessment will form part of the environmental approvals required under State legislation. The assessment involves identifying and mapping locations of protected species and vegetation, communities and evaluation of environmental baseline conditions.

The results of the survey will be incorporated into an Environmental Plan to be submitted to the Department of Mines and Petroleum for approval in early 2017.

Ecologia’s environmental management team has extensive experience in similar undertakings with over 230 environmental projects within the past five years.

UIL Energy’s Managing Director, John De Stefani said,

*“We are excited about progressing the Ocean Hill prospect including the Ocean Hill #2 well design and now the environmental approvals for the scheduled 3D seismic survey. These activities will drive key developments for the company throughout 2017”.*

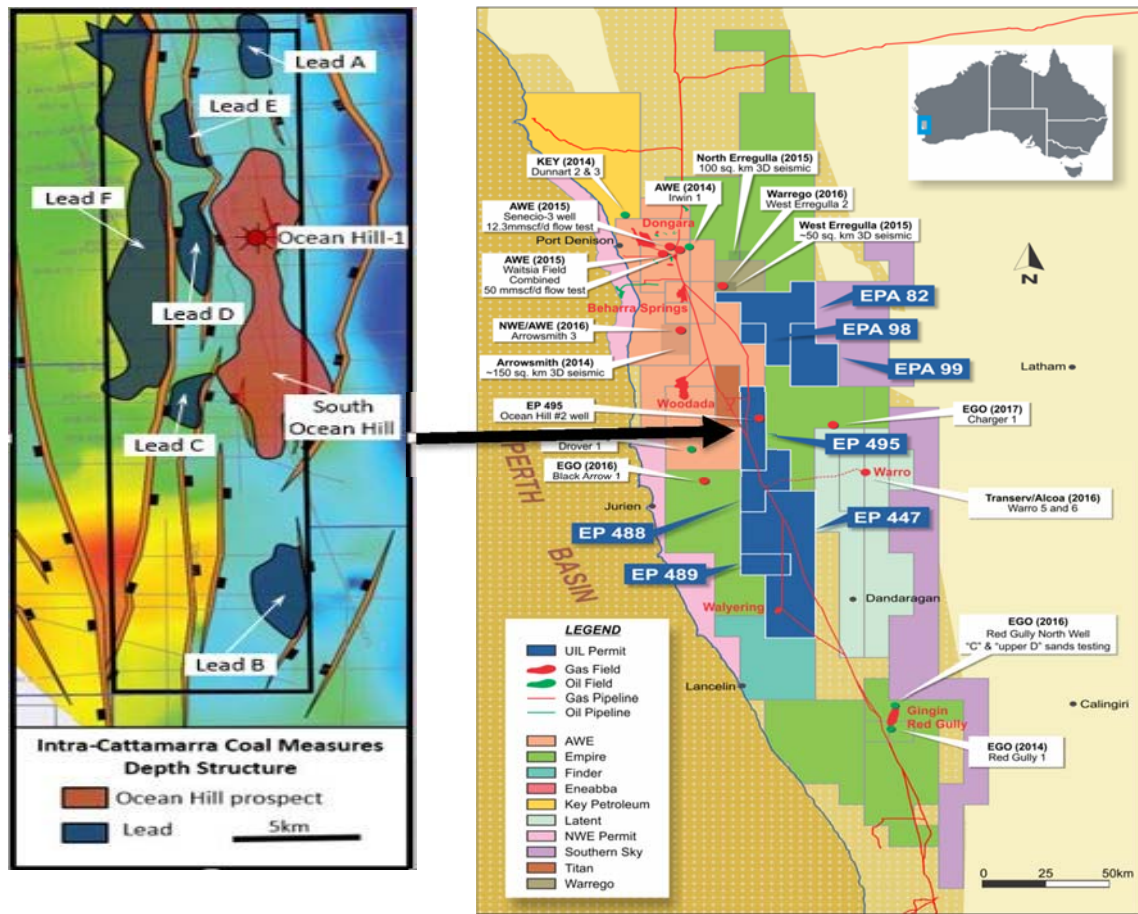
