On this day, trading of Fund units on the ASX will remain available and NAV information will continue to be published on www.betashares.com.au. The Fund will reopen for applications and redemptions by Authorised Participants on 1 April 2019. This close period is not applicable for BetaShares Legg Mason Equity Income Fund (managed fund) and BetaShares Legg Mason Real Income Fund (managed fund).

You must be registered as a unitholder of a Fund as of the Record Date to be eligible to receive a distribution. To be eligible, you will need to have purchased your units prior to the Ex Distribution Date, for the transaction to have been settled and for your unitholding to have been entered on the register as of the Record Date.

The Distribution Reinvestment Plan ("DRP") is operating for each Fund if a distribution is declared. Any DRP elections made by eligible investors must be received by the registrar, Link Market Services, by 3 April 2019.
