## **II. REASONS**

Andrew SKINNER has resigned from his position as director of the Company, effective on 23 April 2014.

Ms Linna YE has been appointed as Non-Executive Director of the Company on 23 April 2014.

In consequence, the Prospectus is updated as follows:

- Page 4: The section on the Board of Directors is amended as follows:
  - o The section on Andrew SKINNER updated as follows:  
"Andrew Bryden SKINNER  
Non-Executive Director  
Resigned on 23/04/2014".
  - o A new section is inserted as follows:  
"Linna YE  
Non-Executive Director"
- Page 10: At the end of the section on Andrew SKINNER, the following paragraph is inserted:  
"Mr SKINNER resigned from his position as Director of the Company on 23 April 2014."
- Page 11: a new section is inserted as follows:  
  
"Linna YE  
*Director*  
(Dip, Prop. Dev – Distinction)  
Linna has been involved in the property development industry for over 10 years as a developer and consultant. Her desire to improve her understanding of property development led to her undertaking a Diploma of Property Development which she graduated with Distinction and she is currently completing her Masters. She has a keen understanding of the business realities of feasibility analysis and the practical experience of ensuring that land is put to its greatest and best use. She has been a director of a number of property development companies. Her understanding of mineral exploration is complemented by her knowledge of development which brings her understanding of how to extract the greatest value from the work done on the ground. Linna is fluent in English, Mandarin, Wuhanese and Cantonese and has lived in Australia for over 20 years."
- Page 20, Section 2.2(ii) is amended as follows:
  - o The second bullet point is deleted
  - o A new bullet point is inserted as follows:  
" Linna YE is a non-executive director Fifth Element. As described above, she has extensive experience in land use and development."

- Page 31, the third paragraph of Principle 4 is updated as follows:

"Due to its size, Fifth Element has appointed an Audit Committee consisting of one Executive Director Chi Ho William LO and two Non-Executive Director Siu-Wing Selwyn CHAN and Linna YE. It has adopted a charter setting out the Audit Committee's role and responsibilities, composition, structure and membership requirements and the procedure for inviting non-committee members to attend meetings."

- Page 124, Section 8.5(c) is updated as follows:

"By letters dated 21 January 2014 the Company has appointed:

- Mr. Andrew SKINNER to the position of Non-Executive Director with a total remuneration of A\$ 35,000, who resigned on 23 April 2014.
- Mr. Noriman Sai Chi MAK to the position of Executive Director with a total remuneration of A\$ 40,000.
- Mr. Siu-Wing Selwyn CHAN to the position of Non-Executive Director with a total remuneration of A\$ 20,000.

By letter dated 23 April 2014, the Company has appointed Ms Linna YE to the position of Non-Executive Director with a total remuneration of A\$30,000."

- Director's Consent

Ms Linna YE, as a Director of the Company, states that she has made all reasonable enquiries and on that basis has reasonable grounds to believe that any statements by the Directors in the Prospectus and the Supplementary prospectuses are not misleading or deceptive and that with respect to any other statements made in this Prospectus and Supplementary Prospectuses by persons other than Directors, Ms Linna YE has made reasonable enquiries and on that basis has reasonable grounds to believe that persons making those other statements were competent to make such statements, those persons having given their consent to the issue of this Prospectus and not withdrawn that consent before lodgement of this Prospectus with ASIC, or to Ms Linna YE's knowledge, before any issue of Shares pursuant to this Prospectus.
