VENTURE REGARDING ITS MYSZKOW DEPOSIT, POLAND STRZELECKI METALS JOINS WITH ELECTRUM GROUP

Highlights:

- **Electrum Group of Companies assumes rights and obligations under earlier MOU to secure exploration rights to the Myszaków molybdenum-copper deposit in Poland;**
- **Joint Venture Agreement executed with completion towards end of month.**

Strzelecki Metals is pleased to announce the signing of a joint venture agreement among Strzelecki Metals, Strzelecki Metals' subsidiary Slasko Krakowska Kompania Górnictwa Metali Sp. z o.o. (SKKGM) and Electrum Strategic Metals III LLC (Electrum), whereby Electrum assumes the rights and obligations of United Moly pursuant to the MOU between Strzelecki Metals and United Moly announced on 22 November 2010.

As previously announced, the joint venture agreement provides for the acquisition of up to a 75% interest in SKKGM by the purchaser, nominated as Electrum Strategic Metals Eastern Europe SA, through:

- The payment of \$US3.5 million by way of partial reimbursement of past expenses, plus agreed interim expenses, on signing and commencement of the joint venture agreement to earn 55% of SKKGM ("commencement"); and
- Exploration expenditure of \$US1 million (mandatory), \$US2 million and \$US3 million (for a total of \$US6 million) by the first, second and third anniversaries of commencement to earn an additional 5%, 5% and 10% respectively of SKKGM.

The joint venture agreement contains generally standard industry terms for the conduct of the business, including provisions for management and for dilution.

SKKGM is the holder of a Polish mineral concession over the Myszkow project in southern Poland, covering an area of 211 square kilometres which includes the Myszkow molybdenum-copper deposit. SKKGM also holds a mineral concession in south west Poland in the highly prospective and copper rich Kupferschiefer basin, adjacent to the

copper mines of Polish miner KGHM Polska Miedz SA, and is also the applicant for a second, contiguous concession in the Kupferschiefer basin.

Electrum Strategic Metals III LLC is a member of the privately-held US based Electrum Group of Companies which is involved in precious metals exploration and development around the world. Further information concerning the Electrum Group is set out in the Attachment.

The Company anticipates completion around the end of March.
