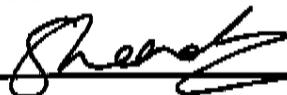

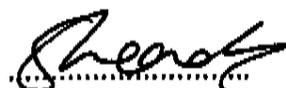
DIRECTIONS
